Introduction

On 5 January 2009 A.M. Martin, D.L.Z Wong, N.J. Dargan and N.B. Kahn were appointed Joint Administrators of Waterford Wedgwood U.K. plc. The administrators have requested that the Directors prepare a Statement of Affairs under Section 47 of Schedule B1 to the Insolvency Act 1986. The notes set out below accompany the Statement of Affairs and form an integral part of it.

The notes set out below are split into two sections:-

- 1. General comments concerning the preparation of the Statement of Affairs.
- 2. Specific comments as regards the method of valuation of the assets and liabilities contained therein.

The following are the Directors and Company Secretary who have been requested by the Administrators to provide a Statement of Affairs:-

1. General comments

- 1.1 The Directors have had limited involvement in the management of the Company since the appointment of A.M. Martin, D.L.Z Wong, N.J. Dargan and N.B. Kahn as Joint Administrators on 5 January 2009.
- 1.2 In the intervening period the Administrators have managed the day to day business and are making arrangements for the disposal of certain assets. The Directors are not aware of the anticipated values to be realised by the Administrators from such disposals.
- 1.3 The Company's management accounts were drawn up to 3 January 2009, the closest practical date to the date of administration which was 5 January 2009.
- 1.4 The Directors' estimate of realisable value is based on their own judgment and having regard to their own assessment of the assets, some of which are specialist in nature with inherent difficulties in estimating realisable values. The estimated realisable values reflect the situation of the Company being in administration. The Directors have not sought a professional valuation of the assets. The Directors note that many factors will influence the actual amount realised and the readers should therefore treat estimates with caution. Other parties may have different views or means of arriving at a valuation.

- 1.5 The Directors have not made adjustments for payments, if any, by the Administrators in respect of sums owing to creditors as at the date of the Statement of Affairs.
- 1.6 No provision has been made in the Statement of Affairs for the costs of Administration or costs of realisation.

Specific comments

1. Investment in subsidiaries.

The book values of investment in subsidiaries are before any allowance for impairment charges. In view of the cross guarantee structure of the Bank of America Facility Agreement dated 10 December 2005 and the €166,208,000 9 7/8ths Mezzanine Notes dated 1 December 2003, the Directors have concluded that it is unlikely any value will be realised from investment in subsidiaries.

2. Debt secured by a fixed and floating charge

Certain of the borrowings of the Waterford Wedgwood Group are secured by a fixed and floating charge, within a cross guarantee structure, over the assets of certain subsidiary companies comprising the Waterford Wedgwood Group, including Waterford Wedgwood U.K. plc. At 5 January 2009, the borrowings secured by a fixed and floating charge over which Waterford Wedgwood U.K. plc is a guarantor are approximately as follows:-

In view of the cross guarantees given by Waterford Wedgwood U.K. plc in relation to the above borrowings, the Directors have included the full amount of the approximate outstanding balance as at 5 January 2009 in the Statement of Affairs.

3. Inter company receivable - Statum Limited

The book value of the inter company receivable from Statum Limited is before allowance for any impairment charge. The recovery of inter company receivables is impacted by the nature of the balance, the local currency restrictions, and the ability of the individual subsidiary to generate a cash surplus to remit to Waterford Wedgwood U.K. plc. The receivable due from Statum Limited is deemed to be quasi equity in nature and the directors estimate that there will be no recovery of this receivable balance.

4. Unsecured creditors

The amount due to unsecured creditors comprises £37,739.42 due to Daejan Investments Limited for office rental and £1,410.00 due to Wragge & Co. The invoice from Daejan Investments Limited covers a rental period 25 December 2008 to 24 March 2009. Due to the contractual nature of the office rental agreement, the Directors have included the full amount of the unpaid invoice from Daejan Investments Limited in the Statement of Affairs. A fellow subsidiary company has previously paid an initial deposit of £157,017.90 to Daejan Investments Limited in relation to this office rental and this amount is still held by Daejan Investments Limited.
