#### 1. ACCOUNTING POLICIES

#### ACCOUNTING CONVENTION

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

#### TURNOVER

Turnover represents the net commission receivable and work done.

#### TANGIBLE FIXED ASSETS

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Short leasehold - Straight line over 15 years
Improvements to property - Straight line over 16 years

Fixtures and fittings - 25% on reducing balance and 10% on reducing balance

Computer equipment - 33% on reducing balance

The short leasehold depreciation is in respect of office premises at Adelaide House, 12 King Edward Road, Brentwood.

#### **DEFERRED TAX**

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

#### HIRE PURCHASE AND LEASING COMMITMENTS

Rentals paid under operating leases are charged to the profit and loss account on a straight line basis over the period of the lease.
