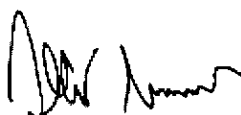

The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, shows the sole asset as an inter-company balance due to the Company of £2,537,000. There were no creditors.

A notice to creditors to submit their claims in the liquidation was advertised in the Independent Newspaper and London Gazette. No creditors were forthcoming as a result of these advertisements.

Tax

All pre-liquidation corporation tax matters were handled by the Company. All outstanding tax returns up to the date of the liquidation have been prepared and submitted to HM Revenue & Customs ("HMRC").

The Liquidators requested confirmation from HMRC that:

- the Company has no outstanding corporation tax returns or liabilities;
- HMRC will not raise enquiries into any pre or post liquidation periods;
- The Company has no outstanding VAT liabilities; and
- HMRC has no objection to the Liquidators calling a final meeting of members to conclude the liquidation.

Tax clearance was given on 28 June 2016 and VAT clearance was given on 8 September 2016.

Distributions

The Company paid a first and final in specie distribution of £2,537,000 to its parent, Teledata (Outsourcing) Limited (in Members' Voluntary Liquidation) on 17 October 2016.

Final meeting of members

I attach a notice of the final meeting of members, which has been convened for 10.00am on 27 February 2017, together with a proxy form. The meeting has been convened pursuant to s94 of the Insolvency Act 1986 and its purpose is to receive an account showing the manner in which winding up has been conducted and the property of the Company disposed of, and of hearing any explanation which may be given by the Joint Liquidators.

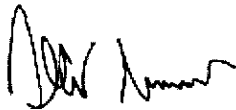
There are no resolutions to be passed at the meeting.

Liquidators' remuneration and expenses
