First - Freehold and leasehold property (if any) including the properties (if any) specified in the schedule to the Debenture and all buildings and machinery from time to time on any such property and all rights and interests (whether or not equitable) in or over land of whatever description both present and future.

Secondly - All book debts both present and future including (without prejudice to the generality of the foregoing) all rights relating to the property of the Company and the benefit of all instruments legal and equitable charges reservation of property rights rights of tracing and unpaid vendors liens and similar and associated rights.

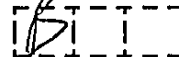
