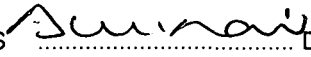
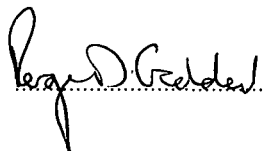
Director's Report:
