Review of business

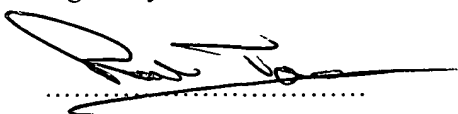
The company remained dormant throughout the year other than acting as a Trustee company.

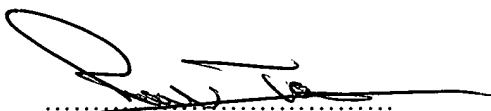
