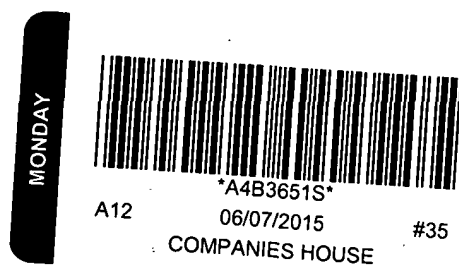

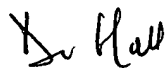
The company is dormant and did not trade during the year.

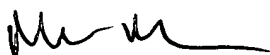
