

- 2 The Applicant shall have his release as administrator of the Company pursuant to section 20(1) (b) of the Act upon the expiry of 14 days after complying with his obligations under Rule 2.52 of the Insolvency Rules 1986.
- 3 Service and advertisement of the Petition be dispensed with
- 4 The Company be wound up by the Court under the provisions of the Act
- 5 The costs of and incidental to the Petition be paid as an expense of the administration of the Company
