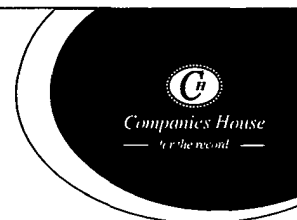

Figure 1. The effect of the concentration of the *Agrobacterium* suspension on the transformation efficiency of *Agrobacterium* strains. The *Agrobacterium* strains were grown in YEA medium for 24 h at 28 °C. The cell concentration of the strains was adjusted to 10⁸ cells/ml. The cell suspension was then diluted with distilled water to the concentration of 10⁶ cells/ml. The cell suspension was then mixed with the plant tissue and the transformation efficiency was determined. The results are shown in Table 1.

Figure 1. The effect of the concentration of the *Agrobacterium* strain on the transformation efficiency of *Agrobacterium* strain 1024. The concentration of the *Agrobacterium* strain 1024 was 10⁶ cells/ml (○), 10⁷ cells/ml (□), 10⁸ cells/ml (△), 10⁹ cells/ml (◇), and 10¹⁰ cells/ml (×). The transformation efficiency was determined by the number of transformants per 10⁶ cells of *Agrobacterium* strain 1024. The error bars represent the standard deviation of three independent experiments.

The concentration of the *Agrobacterium* suspension was 10⁶ cells/ml (○), 10⁷ cells/ml (□), 10⁸ cells/ml (△), and 10⁹ cells/ml (◇). The error bars represent the standard deviation of three independent experiments.

Figure 1. The effect of the number of trials on the mean number of correct responses. The number of correct responses increased with the number of trials. The number of correct responses was significantly higher for the 10 trials condition than for the 5 trials condition ($p < 0.05$).


