IT IS HEREBY ORDERED as follows:

- In respect of those Administrations, Bankruptcies, Creditors' Voluntary Liquidations, Compulsory Liquidations and Members' Voluntary Liquidations as listed in the Schedule to this Order and which are the subject of proceedings in County Court, the Companies Court or other District Registries in England and Wales, those proceedings be transferred to the High Court, Business and Property Court in Leeds, Insolvency and Companies List (ChD) solely for the purpose of this application and thereafter transferred back to the relevant Court.
