WOC Realisations Limited (formerly Whittard of Chelsea Limited)("Whittard") and BCC Realisations Limited (formerly Boaters Coffee Co. Limited)("Boaters")(Both in Administration)(together "the Companies")

I write further to my appointments as Joint Administrator of the above Companies and attach a copy of my Statements of Proposals ("Proposals") in accordance with paragraph 49 of Schedule B1 to the Insolvency Act 1986.

As you will note from the Proposals, there is no prospect of any funds becoming available to unsecured creditors other than by virtue of the prescribed part. As a consequence, I do not propose to summon meetings of creditors. If, however, creditors whose debts amount to at least 10% of total debts of Whittard and/or Boaters make a request in the prescribed form within 12 days of these Proposals being sent out, a meeting for Whittard and/or Boaters will be held. A copy of the prescribed forms (Form 2.21B) for both Whittard and Boaters are enclosed in case you wish to request such meetings. I would draw your attention to the provisions of Rule 2.37 of the Insolvency Rules 1986 which provide that if a meeting is requested, it will only be held if the expenses of summoning and holding such a meeting are paid by the creditor or creditors making the request and if security is first deposited with me for payment. The meeting may subsequently resolve that the expenses of summoning and holding the meeting are paid out of the assets of the relevant company as an expense of the administration.

In the event that a meeting is not held, the Proposals will be deemed to be accepted. The Joint Administrators' remuneration in reference to the Companies will be agreed with the secured creditor and, if appropriate, the preferential creditors in accordance with the provisions of Rule 2.106(5A) of the Insolvency Rules 1986.

Introduction, background and circumstances giving rise to the appointment

1.1 Introduction

On 23 December 2008 the Companies entered administration and A Swarbrick and AM Hudson were appointed to act as Joint Administrators. This document, including its appendices, constitutes the Joint Administrators' Statements of Proposals to Creditors ("Proposals") pursuant to paragraph 49 of Schedule B1 to the Insolvency Act 1986 and Rule 2.33 of the Insolvency Rules 1986.

Certain statutory information relating to the Companies and the appointments of the Joint Administrators are provided at Appendix A.


1.2 Background

WOC Realisations Limited, formerly trading as Whittard of Chelsea Limited ("Whittard") was a UK-based retailer and wholesaler of specialist coffees, teas and associated products, operating from 130 retail stores across the UK, two warehouses and a head office based in Stockwell, London.

BCC Realisations Limited, formerly trading as Boaters Coffee Company Limited ("Boaters"), was a UK-based retailer and wholesaler of flavoured coffees that provided product directly to Whittard, as well as selling to customers online. Boaters operated from one warehouse and a head office based in Bedfordshire.

Both Companies were acquired by the Baugur Group in 2005. Whittard was paired with one of Baugur's other investments, Julian Grave Health Stores. In 2007 it was discovered that Whittard was a 'poor fit' with Julian Graves and the two operations were separated. A new management team was recruited in late-2007 to begin to implement a restructuring and recovery plan for the business.

The structure of the Baugur Group, as far as it relates to the Companies, is illustrated below:



The Companies employed approximately 950 staff – 850 in retail stores and 100 in head office/support roles.

Both Companies were funded by Landsbanki Islands hf ("Landsbanki"), which has fixed and floating charges over the assets of both Companies.

We understand that the Baugur Group UK have also loaned Whittard c.£1.0m, and that Barney Holdings Limited has also loaned Whittard c.£263k.

1.3 Circumstances Giving Rise to the Appointment of the Administrators

Due to trading pressures facing the retail sector during 2008, combined with the problems faced by the Icelandic banks and Icelandic investors, which subsequently placed pressure on the funding available to the Companies, it was not possible for the management team to effectively implement the turnaround plan as had been envisioned in 2007.

Consequently, in late-October 2008, the Companies engaged KPMG LLP to conduct an Accelerated M&A (AMA) process to find a new investor or buyer for the Companies. When this AMA process did not succeed in identifying any investors or buyers who were willing to complete outside an insolvency process, the directors of the Companies resolved to appoint Joint Administrators. A Swarbrick and AM Hudson were then appointed Joint Administrators and subsequently sold the businesses and assets, excluding cash and debtors, of the Companies to Hamsard 3146 Limited (Hamsard) (a subsidiary of Epic Private Equity LLP (Epic)) for a total consideration of £600,000.

Further details of the events leading up to this pre-packaged sale of the businesses and assets of the Companies are included at section 2.2.1 of these Proposals.

2. Purpose, conduct and end of administration

2.1 Purpose of the Administration

The purpose of an administration is to achieve one of three objectives:

- a. To rescue the company as a going concern;
- b. To achieve a better result for the company's creditors as a whole than would be likely if the company were wound up (without first being in administration);
- To realise property in order to make a distribution to one or more secured or preferential creditors.

Insolvency legislation provides that objective (a) should be pursued unless it is not reasonably practicable to do so or if objective (b) would achieve a better result for the company's creditors as a whole. Objective (c) may only be pursued if it is not reasonably practicable to achieve either objective (a) or (b) and can be pursued without unnecessarily harming the interests of the creditors of the company as a whole.

The Joint Administrators concluded that objective (a) could not be achieved because the Companies had been subject to a marketing process prior to the administration and this marketing process did not identify any parties willing to purchase the Companies outside of an insolvency process, for example, by purchasing the shares of the Companies. Consequently they have pursued objective (b). Further information on how this objective has been pursued is given in section 2.2 below.

2.2 Conduct of the Administration

2.2.1 Pre-packaged Sale of the Business and or Assets

On 23 December 2008 the Joint Administrators completed the sale of the Companies' businesses and assets to Hamsard (a subsidiary of and funded by Epic) for a total consideration of £600,000. As far as we are aware, there is no connection between Epic/Hamsard, and the directors, former directors and shareholders of the Companies, or the secured creditor, Landsbanki. Also, as far as we are aware, none of the directors of the Companies have given any personal guarantees in respect of the Companies' debts.

Further information regarding the transaction is given below. The information is provided to the best of our knowledge.

Ernst & Young LLP was originally instructed by Landsbanki to monitor an AMA process (previously referred to in section 1.3 of these Proposals) which the Companies commenced in late October 2008. The Companies undertook the AMA process because the directors had formed the opinion that it was in the best interests of the creditors of the Companies for the businesses to be sold quickly, thereby preserving asset values and employment given the proximity to the new year and that a sale after the Christmas trading was less likely.

As part of the AMA process, the businesses were fully marketed for sale by the Companies and their advisors, KPMG, and a comprehensive information memorandum, and data room were prepared and made available to a shortlist of approximately 20 potential interested parties. The interested parties approached by KPMG included trade, private equity and distressed investors from the UK and overseas. The sale process also received significant coverage in the press, and as such, any party not directly approached by KPMG as a potential buyer, also had the opportunity to submit an offer for the businesses to the Companies' directors and shareholders.

Towards the end of the AMA process, indicative offers were received from three distressed investors and one trade buyer. The trade buyer later withdrew and only one acceptable offer-from a distressed investor – remained. This was from Epic, for a total cash consideration of £650,000.

On 22 December 2008, following protracted negotiations, Epic advised that it would not proceed with its offer. As a result, the directors stated their intention to appoint Joint Administrators. Epic approached A Swarbrick and AM Hudson of Ernst & Young (as prospective Administrators), indicating they would be prepared to acquire all of the businesses and assets of the Companies (with the exception of debtors, cash and bank balances) in a pre-packaged transaction for a total cash consideration of £550,000.

In reviewing Epic's offer, we considered alternative strategies to realise the Companies' assets. These included either trading administrations with a view to a subsequent going concern sale of the businesses; or trading administrations followed by large-scale site closures and the subsequent sale of remaining stock to a 'clearance' buyer.

In reference to the strategy of trading the Companies with a view to a subsequent going concern sale of the businesses, it was the Joint Administrators' view that, given the following factors:

- the situation currently facing the UK retail sector generally;
- ▶ the time of the year and trading projections post-Christmas;
- ▶ the results of efforts to sell the business already through the AMA process (when buyers would have more benefit of the seasonal trade);

there was little, if any, prospect of a better offer being forthcoming as a result of a full marketing process during administration and there was a real risk that, once the cash-generative Christmas season had passed, no offers would be forthcoming at all.

As a result, the alternative strategy of trading to realise as much value from the stock in the remainder of the Christmas/end-of-year period, and then sell the remaining stock to a 'clearance' buyer was also considered.

The Joint Administrators carried out an analysis of the potential return under this strategy on both a high and low case, and compared these potential returns to the return realisable under Epic's offer. The conclusion was that there was only a marginal difference in the estimated outcomes, and that the high-case trading administration had the potential to realise more value for creditors. Accordingly, accepting the pre-packaged offer of £550,000 could not be justified.

Epic was informed of this conclusion and subsequently increased its offer to £600,000. This brought Epic's offer much closer to the estimated high outcome on a trade-out of the businesses, with the additional benefit of preserving jobs and removing uncertainty around realising the stock.

Accordingly, we concluded that, given the outcome of the earlier sale efforts and the estimated outcome and potential risks on a trade-out, this revised offer should be recommended to Landsbanki, as fixed and floating charge holder. As a consequence it was not necessary to seek sources of working capital funding for administration trading.

The overall benefit to creditors of the transactions can be summarised as follows:

- 1. All employees would transfer to the new business and, as such, their entitlements would be protected and avoid crystallising further unsecured claims against the Companies' assets.
- 2. A dividend to any remaining preferential creditors would be available.

- A payment to unsecured creditors of Whittard to the maximum value of the prescribed part of £600,000 would be available.
- A payment to the unsecured creditors of Boaters under a prescribed part would be available.
- There would be a partial repayment of the debt due to Landsbanki, although this would be significantly less than the total value of their outstanding debt.

Immediately following our appointments as Joint Administrators, we consulted with Lansdbanki, the Companies' largest creditor, before the offer was accepted and Landsbanki gave its consent to the transactions. The final transactions were the pre-packaged sales of the businesses and assets of the Companies, completed on 23 December 2008. The total consideration of £600,000 has been paid by Hamsard to the Companies. The assets sold to Hamsard (to the extent that the Companies had a right, title or interest to sell) comprised the following:

The realisations have, in the majority, been allocated to assets secured by Landsbanki's floating charges, with £1 being apportioned to the fixed charge assets (goodwill and intellectual property of Whittard). Asset realisations for assets excluded from the prepackaged sales are discussed below.

2.2.1.1 Cash at bank and cash at the Companies on appointment

Upon appointment, the Joint Administrators notified the Companies' previous banks to transfer any credit balances to the Joint Administrators' accounts.

The Joint Administrators have received c.£2.6m from these pre-appointment accounts: £2.6m in respect of Whittard (before the application of bank charges and other set-off applied by the Companies' main pre-appointment trading bank), and £7k in respect of Boaters.

We are in correspondence with the Companies' main pre-appointment trading bank as to the potential recovery of these funds and, in addition, an amount which they have also retained pre-appointment in the order of c.£600k. We anticipate that a minimum c.£390k in pre-appointment balances currently retained will subsequently be released into the Companies' estates, the difference reflecting the set-off of pre-appointment liabilities and charges.

2.2.1.2 **Debtors**

Intercompany debtors - Whittard Inc.

At the date of the appointments there was an intercompany balance of c.£1.8m due from Whittard Inc to Whittard. This debt arose as a result of Whittard Inc being dependant on funding from Whittard in order to fund its US operations. As a result of the administration of Whittard, and independent funding not being available from its directors, Whittard Inc was subsequently placed under Chapter 7 Bankruptcy proceedings in the US Bankruptcy Courts.

The Joint Administrators will submit a claim in respect of this intercompany debt, however, we estimate it is unlikely that a distribution will be received from Whittard Inc.

Trade debtors

Whittard's debtors ledger indicated debtors of c.£882k at the date of the appointment of the Joint Administrators. Further review and reconciliation of this ledger has reduced this balance to c.£828k, which is comprised of 33 debtors. There are a number of issues of which we are aware in respect of the collection of these book debts. The major issue is that c.£345k of this balance is owed by Whittard Inc. which is, as detailed above, subject to Chapter 7 Bankruptcy proceedings in the US. In addition, several other debtors have been identified as being in financial difficulty or alternatively have asserted that they are net creditors of the Companies.

Consequently, the Joint Administrators do not believe it is likely that the full balance of the Whittard's debtors ledger will be recovered.

Boaters has book debts of c.£489k, with Whittard owing c.£251k of this debt. An analysis of the composition, geographic location and ageing of these book debts indicates that these are also unlikely to be realised in full.

To date c.£135k and c.£3k has been collected from Whittard and Boaters debtors respectively. A further amount of c.£55k was paid by debtors into the pre-appointment bank account of Boaters, however (and despite frequent requests to the pre-appointment trading bank), these funds have not been released into the administration accounts. We are currently pursuing the release of these funds into the Boaters' estate.

The Joint Administrators have appointed a debt collection agency, JP Associates, to assist in the collection of book debts on a no collection, no fee basis, with fees set at 10% of the recoveries made.

2.2.1.3 Prepayments

Business rates

According to the Companies' books and records at the date of appointment, prepayments in relation to business rates were c.£178k, and in the majority, relate to Whittard. The Joint Administrators have contacted all known local rating authorities to notify them of the Administrations and of the transfer of liability regarding business rates to Hamsard, or the landlords, depending whether the property continues to be occupied by Hamsard, or we have attempted to surrender the lease to the landlord. As a result, to date, c.£44k has been refunded to the Companies.

Insurance

Willis, the Companies' pre appointment insurers have confirmed that an amount of c.£47k is due to be refunded to the estates, arising as a result of the cancellation of these preappointment insurance policies.

Rent received under sub-licence

The Companies leased c.130 properties from a variety of landlords, including both individuals and companies. Pursuant to the license to occupy granted as a condition of the SPA, Hamsard has taken occupation of these premises and, as per the licence, are currently

providing the Joint Administrators with funds to remit to landlords in respect of rent for occupation of the premises.

An additional realisation in respect of rent has occurred due to the timing of the date of the Joint Administrators' appointments and the commencement of the next period's rental date. As the rent prior to the Joint Administrators' appointment was paid up to either 24 or 31 December 2008 for a number of properties, and Hamsard will pay for occupation from 23 December 2008 onwards, the Joint Administrators have realised an additional c.£132k in rental income.

Rent received under tenancy arrangements

In respect of several of the properties leased by the Companies prior to the Joint Administrators' appointments, the Companies' had entered into subleasing arrangements with a number of tenants. These have included both flats above shops and individual units at the Companies' Head offices in Stockwell. The rental income in respect of these properties received to date is c.£55k.

The Joint Administrators will receive further income in respect of these tenancy arrangements during the course of the Administrations, although it is our intention to ensure these subleases are either assigned to Hamsard as part of any overall property lease assignment, or to the ultimate landlord. If assignment is not possible, the Joint Administrators will provide notices of removal to those tenants.

Pre-appointment VAT reclaim

Boaters' records indicate a potential pre-appointment VAT refund of c.£14k. The Joint Administrators are arranging for a repayment claim to be submitted.

2.2.2 Creditors

2.2.2.1 Secured creditors

The secured creditor of the Companies at the date of the appointments of the Joint Administrators is Landsbanki and the split of the debt across the Companies is as follows:

2.2.2.2 Preferential creditors

TUPE

In accordance the SPA, Hamsard's acquisition of the businesses and assets of the Companies constituted sales of the businesses as going concerns, and as such TUPE regulations apply.

Claims not subject to TUPE

TUPE does not however, oblige the transferee in a pre-packaged sale to pay the arrears of wages due to employees. As the Joint Administrators would be obliged to pay these preferential amounts in the administrations irrespective, the Joint Administrators and Hamsard agreed in the SPA, that the Joint Administrators would pay the arrears of wages (from the date of appointment) when the affected employees' wages next fell due.

The amount paid to the hourly paid employees of both Whittard and Boaters as preferential creditors is summarised below:

We currently estimate remaining preferential creditors of c.£5k for Whittard and Boaters, in respect of potential outstanding claims for employees' salaries, holiday pay and pension contributions.

2.2.2.3 Unsecured creditors

Trade creditors

These creditor claims continue to be submitted. It is estimated that total non-preferential claims for Whittard will be in the region of c.£5,730k and for Boaters, c.£299k.

Retention of title

In accordance with the SPA, Hamsard has been corresponding with suppliers in relation to Retention of Title (ROT), and have advised the Joint Administrators that a number of settlements have occurred and are also pending resolution. The Joint Administrators will reduce supplier claims accordingly on any settlement information given by Hamsard.

Intergroup creditors

As noted in section 1.2, the Baugur Group UK loaned Whittard c £1.0m, and Barney Holdings Limited has also loaned Whittard c.£263k.

2.2.3 Dividend prospects and meetings of creditors

The Joint Administrators are of the opinion that the Company has insufficient property to enable a distribution to be made to unsecured creditors other than by virtue of the prescribed part and consequently, in accordance with the provisions of paragraph 52(1) of Schedule B1 to the Act, they do not intend to call an initial creditors' meeting.

The Joint Administrators will be obliged to call an initial meeting of creditors if it is requested by creditors of the Company whose debts amount to at least 10% of the total debts of the Company. The request must be made within 12 days of the date on which these proposals are sent out (or such longer period as the court may allow) and must be in the prescribed form. The creditor summoning the meeting must lodge with the Joint Administrators a deposit as security for the expenses of summoning and holding the meeting. Further information is provided in the covering letter accompanying these proposals.

2.2.4 Future Conduct of the Administration

The Joint Administrators shall continue to realise the assets of the Companies in order to make distributions to the secured creditor and preferential creditors (if any) and to set aside prescribed parts for the unsecured creditors of the Companies.

The Joint Administrators' actions will include:

- Pursuing the return of pre-appointment cash balances;
- Seeking the assignment to Hamsard of leases, in respect of properties Hamsard wishes to maintain;
- Seeking surrenders of the leases, in respect of properties that Hamsard has ceased to occupy:
- If necessary, reviewing the tax affairs of the Companies;

Dealing with unsecured claims, if appropriate

2.2.5 The End of the Administration

It is proposed that, at the end of the Administrations, the Companies will move straight into Creditors' Voluntary Liquidation upon the filing with the registrar of companies of notices pursuant to paragraph 83 of Schedule B1 to the Insolvency Act 1986.

It is proposed that the Liquidators of the Companies will be A Swarbick and AM Hudson of Ernst & Young LLP. In accordance with paragraph 83(7) of Schedule B1 to the Insolvency Act 1986 and Rule 2.117(3) of the Insolvency Rules 1986, creditors may nominate a different person as the proposed liquidator(s), provided that the nomination is made after the receipt of these proposals and before the proposals are approved. It should be noted in this regard that a person must be authorised to act as an insolvency practitioner in order to be appointed as liquidator.

The Statements of Affairs for Boaters are identical. A copy of this Statement of Affairs with the individual directors' Statements of Truth and our comments on this Statement of Affairs is attached at Appendix C.

The Joint Administrators also consider that the realisable values of assets may be lower than the realisable values included by the directors in the Statement of Affairs for both Whittard and Boaters. This is due to the following:

- Assets sold as part of the pre-packaged sale of the business and assets the values realised in respect of these assets were significantly lower than the realisable values included by the directors in the Statement of Affairs; and
- Assets excluded from the pre-packaged sale of the business and assets the realisable values of these assets may be lower than those included by the directors in the Statement of Affairs due to:
 - The impact of the administration on realisable value of assets;
 - ► The current economic environment.

As a result, the amount available to creditors may be less than indicated in the Statement of Affairs

The Directors have also estimated creditors' claims as at the date on which the Companies entered administration. Creditors continue to lodge their claims with the Joint Administrators and consequently it is likely that the total of liabilities will increase.

4. Prescribed part

The prescribed part is a proportion of floating charge assets set aside for unsecured creditors pursuant to section 176A of the Insolvency Act 1986. The prescribed part applies to floating charges created on or after 15 September 2003.

The Joint Administrators estimate, to the best of their knowledge and belief, that:

In reference to Whittard:

- ▶ the value of the prescribed part is c.£600k
- the value of the Company's net property is c.£3,322k.

In reference to Boaters:

- the value of the prescribed part is c.£35k
- the value of the Company's net property is c.£154k.

The Joint Administrators do not intend to make an application to the court under section 176A(5) of the Insolvency Act 1986 for an order not to distribute the prescribed part.

5. Administrators' remuneration and disbursements and payments to other professionals

5.1 Remuneration

The statutory provisions relating to remuneration are set out in Rule 2.106 of the Insolvency Rules 1986. Further information is given in the Association of Business Recovery Professionals' publication 'A Creditors' Guide to Administrators' Fees', a copy of which may be accessed from the web site of the Insolvency Practitioners Association at http://www.insolvency-practitioners.org.uk (follow 'Regulation and Guidance" then 'Creditors' Guides to Fees'), or is available in hard copy upon written request to the Joint Administrators.

In the event that creditors' meetings are not requisitioned and creditors' committees are not formed, the Joint Administrators will seek to have their remuneration fixed by the secured creditor and, if appropriate, the preferential creditors in accordance with Rule 2.106(5A) of the Rules. The Joint Administrators will ask for their remuneration to be fixed on the basis of time properly given by them and their staff in dealing with matters arising in the Administration.

Details of time spent and charge out rates will be provided to the secured creditor and, if appropriate, the preferential creditors and will be made available to any other creditor upon written request to the Joint Administrators.

5.2 Disbursements

Statement of Insolvency Practice No. 9 (SIP 9), published by the Association of Business Recovery Professionals, divides disbursements into two categories.

Category 1 disbursements are defined as specific expenditure relating to the administration of the insolvent's affairs and referable to payment to an independent third party. Such disbursements can be paid from the insolvent's assets without approval from the creditors' committee or the general body of creditors. It is our policy to disclose Category 1 disbursements drawn but not to seek approval for their payment.

For details of Category 1 disbursements to date, please refer to the payments section of the Joint Administrators' Statements of receipts and payments as discussed at section 6.1 and attached at Appendix D (Whittard) and Appendix E (Boaters). The Joint Administrators are prepared to provide such additional information as may reasonably be required to support the disbursements drawn.

Category 2 disbursements are charges made by the Joint Administrators' firm that include elements of shared or overhead costs. SIP 9 provides that such disbursements are subject to approval as if they were remuneration. The Joint Administrators do not intend to charge Category 2 disbursements in this case.

#### Joint Administrators' Comments on Directors Statement of Affairs

The Joint Administrators consider that the realisable values of assets may be lower than the realisable values included by the directors in the Statement of Affairs. This is due to the following:

- 1. Assets sold as part of the pre-packaged sale of the business and assets the values realised in respect of these assets were significantly lower than the realisable values included by the directors in the Statement of Affairs; and
- 2. Assets excluded from the pre-packaged sale of the business and assets the realisable values of these assets may be lower than those included by the directors in the Statement of Affairs due to:
  - a. The impact of the administration on realisable value of assets;
  - b. The current economic environment.

As a result, the amount available to creditors may be less than indicated in the Statement of Affairs.

The directors' Statement of Affairs does not include a list of the names and addresses of the company's creditors with details of their debts and any security held. The Joint Administrators have since received details of unsecured creditors, which are now attached to the Statement of Affairs. The total unsecured creditors' amount, however, is based on a report generated on 15 January 2009. The directors have indicated they are not able to produce reports as at the date of the appointment of the Administrators. There is therefore the possibility that, in the intervening period, there may have been movements in individual balances and as such, due to incorrect cut-offs, the total amount owed to unsecured creditors may therefore be higher than the amount estimated by the directors in the Statement of Affairs.

The Statement of Affairs does not attach information on shareholders of the Company.
