#### 1. ACCOUNTING POLICIES

# a) Basis of preparation of financial statements

The following financial statements have been prepared on the historical cost convention and in accordance with applicable accounting standards.

#### b) Consolidation

The company has taken advantage of the exemption given by Section 228(2) of the Companies Act 1985 not to prepare consolidated financial statements on the grounds that the company itself is a subsidiary company (see Note 6).

# c) Cashflow statement
