The Companies' statutory obligations can be found in Sections 514 and 515 of the Act Unless we receive notice from the Companies that it has made an application to the court within 21 days of the date on which our statement of no circumstances is deposited at your registered office (the "Date of Deposit"), we must within a further 7 days send a copy of our statement of no circumstances to the Registrar of Companies
