

2.1 Basis of preparation of financial statements

The company has taken advantage of the small companies' exemptions in preparing the directors' report and from preparing a strategic report.

The consolidated financial statements of Retirement Bridge Group Holdings Limited and Retirement Bridge Investments Limited can be obtained from Cross House, Westgate Road, Newcastle Upon Tyne, NE1 4XX.

From 30 April 2019, Retirement Bridge Investments Limited purchased 100% of the share capital in the company. Retirement Bridge Investments Limited is now the parent undertaking of the smallest and largest group of undertakings to consolidate these financial statements at 30 September 2019.
