REPORT ON THE MEETINGS OF CREDITORS AND MEMBERS HELD AT THE BARBICAN CENTRE, CINEMA 1, SILK STREET, LONDON EC2Y ON 20 MAY 1997

- I, David Julian Buchler, of Buchler Phillips, Chartered Accountant, introduced myself and advised creditors that the meeting of creditors had been summoned pursuant to Section 3 of the Insolvency Act 1986.
- I then introduced to the meeting my co-administrator, Lee Manning, my senior manager, Michael Crosby, Barry Townsley of Townsley & Co., stockbrokers and corporate finance experts and lastly Stephen Lister and Michael Prior of Nabarro Nathanson, solicitors.
- I advised the meeting that as convenor of the meeting, I was Chairman for the purpose thereof. I then went through, in detail, the Administrators' proposal and the Modifications to the proposals.
