The directors present their report and the audited accounts of Trust Union Properties Residential Developments Limited (the 'Company') for the year ended 31 March 2012.

### **Business Review**

The principal activity of the Company was that of property investment and management, specialising in residential housing. The Company's property holdings were sold in March 2000 and the business undertaking was sold in December 2000. The Company has not made any further investments since that time although it continues to seek investment opportunities.

The Company made a loss for the year of £31,000 (2011: £28,000). The directors are not recommending the payment of a dividend. (2011: nil)

The Company does not currently have sufficient financial resources but has the continuing financial support of its ultimate parent company, TR Property Investment Trust Plc (the 'Group'). The Group has provided a letter to the Company setting out its financial support to enable the Company to meet all of its present and future obligations as and when they fall due, to the extent the Company is unable to do so. As a consequence the directors believe that the company is well placed to manage its business risks going forward. Accordingly, the financial statements have been prepared on a going concern basis, which assumes that the company will continue in operational existence for the foreseeable future and be able to meet its liabilities as they fall due.

### **Directors**

The directors of the Company during the year ended 31 March 2012 were those listed above.

No director had any interests in the share capital of the Company. The interests of the directors in the share capital of TR Property Investment Trust plc, the ultimate holding company, at the beginning of the year and at the end of the year are shown below:

## NOTES TO THE ACCOUNTS for the year ended 31 March 2012

### **1 Accounting Policies**

#### **a) Basis of Accounting**

The accounts have been prepared under the historical cost basis of accounting and have been prepared in accordance with the Companies Act 2006 and applicable United Kingdom accounting standards. All of the Company's operations are of a continuing nature. The principal accounting policies are set out below.

#### **b) Income and Expenses**

Income and expenses are recognised on an accruals basis.

#### **c) Taxation and Deferred Taxation**

The charge for taxation is based on the profit for the year and takes into account taxation deferred because of timing differences between the treatment of certain items for taxation and accounting purposes. Deferred taxation is provided using the liability method on all timing differences, calculated at the rate at which it is anticipated the timing differences will reverse, based on tax rates and laws enacted or substantially enacted at the balance sheet date. Deferred tax assets are recognised only when, on the basis of available evidence, it is more likely than not that there will be taxable profits in the future against which the deferred tax asset can be offset.

#### **d) Cashflow**

The Company is a wholly owned subsidiary of TR Property Investment Trust plc, and is therefore included in its consolidated financial statements which are publicly available, consequently the Company has taken advantage of the exemption from preparing a cashflow statement under the terms of Financial Reporting Standard 1 (Revised 1996).

### **2 Administrative Expenses**

The audit fee of £1,250 (2011: £1,000) has been borne by another group entity.

No director earned any remuneration from the Company during the year (2011: nil).  
No amounts were payable by the Company or any third party in respect of the directors' services to the Company for the year (2011: £nil).
