Opinion

We have audited the financial statements of L&C Overseas Limited for the year ended 31 March 2019 which comprise the Balance Sheet and Notes to the Financial Statements, including a summary of significant accounting policies. 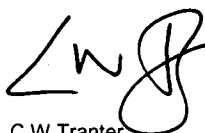
