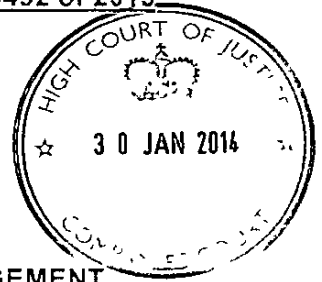

- (6) the hearing fixed for the 28 February 2014 at 2 00 pm be vacated
