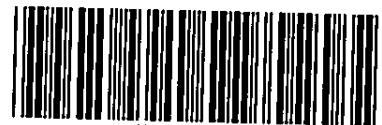



Basis of preparation
