

PROCEEDINGS AT GENERAL MEETINGS.

10. At any General Meeting a Resolution put to the vote of the Meeting shall be decided on a show of hands unless a poll is (before or on the declaration of the result of t' a show of hands) demanded by the Chairman or any member in person or by proxy. Unless a poll is so demanded a declaration by the Chairman that a Resolution has on a show of hands been carried or carried unanimously, or by a particular majority, or lost, an entry to that effect in the book containing the minutes of the proceedings of the Company shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against such Resolution. The demand for a poll may be withdrawn. In the event of an equality of votes the Chairman shall not have a second or cauting vote.

DIRECTORS.

- 11. A Director shall also be capable of voting in respect of such contracts or arrangements, where he has previously disclosed his interest to the Company, or in respect of his appointment to any office or place or profit under the Company, or in respect of the terms thereof and may be counted in the quorum at any Meeting at which any such matter is considered.

SECRETARY.

15. The first Secretary of the Company shall be the person or persons named as Secretary in the Statement delivered to the Registrar of Companies prior to the incorporation of the Company and deemed to be appointed accordingly.

DORROWING POWERS OF THE DIRECTORS.

16. The Directors of the Company may exercise all the powers of the Company to benrow money, whether in excess of the nominal amount of the share capital of the Company for the time being issued or not and to mortgage or charge its undertaking property or uncelled capital, or any part thereof, and subject to section 80 of the Act to issue debentures, debenrue stock and other securities whether outright or as seeking, for any debt liability or obligation of the Company or of any third party.

ALTERNATE DIRECTORS.

17. Any Director may in writing appoint any person to be his alternate to act in his place at any meeting of the Directors at which he is unable to be present. Every such alternate shall be entitled to notice of meetings of the Directors and to attend and vote there as a Director when the person appointing him is not personally present and where he is a Director to have a separate vote on behalf of the Director has is representing in addition to his own vote. A Director may at any time in writing rovoke the appointment of an alternate appointed by him. The remuneration of such an alternate shall be payable out of the remuneration psychola to the Director appointing him and the proportion thereof shall be agreed between them. An elternate need not hold any share qualification.

INDEMNITY.

18. Subject to Section 310 of the Act and in addition to such indemnity as is contained in Regulation 118 of Table 'A' every Director, Officer or Official of the Company shall be indemnified out of the funds of the Company against all costs, charges, losses and expenses and liabilities incurred by him in the execution and discharge of his duties or in relation thereto.

DISQUALIFICATION OF DIRECTORS

- 19. The office of a Director shall be vacated:-
 - (1) If by notice in writing to the Company he resigns the office of Director,
 - (2) If he ceases to be a Director by virtue of Section 291 of the Act.
 - (3) If he becomes bankrupt or insolvent or enters into any arrangement with his creditors,
 - (4) If he becomes of unsound mind.
 - (5) If he is prohibited from being a Director by any order made under Section 295 to 300 of the Act,
 - (6) If he is removed from office by a resolution duly passed under Section 303 of the Act.
