#### 1. Recital

- (iv) pursuant to any court order in relation to each and every company or individual to which or to whom I have been appointed an office holder, such term including but not limited to the offices of receiver (of whatever type), administrator, liquidator (whether or not provisional), trustee in bankruptcy, nominee or supervisor.

# 3. Continuity of Power of Attorney
