AUDITORS' REPORT TO THE DIRECTORS OF HAREWOOD INTERNATIONAL LIMITED PURSUANT TO PARAGRAPH 24 OF SCHEDULE 8 TO THE COMPANIES ACT 1985

We have examined the abbreviated accounts on pages 3 to 5 together with the full financial statements of Harewood International Limited prepared under Section 226 of the Companies Act 1985 for the year ended 31st March 1994. We planned and performed our audit so as to obtain all the information and explanations which we considered necessary in order to provide us with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or other irregularity or error. In forming our opinion we also evaluated the overall adequacy of the presentation of information in the financial statements.

NOTES TO THE ABBREVIATED ACCOUNTS

FOR THE YEAR ENDED 31ST MARCH 1994

1. ACCOUNTING POLICIES

Accounting convention:

The financial statements have been prepared under the historical cost convention.

Tangible fixed assets:

Tangible fixed assets are stated at cost less depreciation.

Depreciation is provided on all tangible fixed assets, at rates calculated to write off the cost or valuation, less estimated residual value of each asset over its expected useful life, as follows:-

Property improvements 10% per annum straight line basis Fixtures & fittings 15% per annum reducing balance basis Motor vehicles 25% per annum reducing balance basis

Stocks:

Stocks are stated at the lower of cost and net realisable value.

Deferred taxation:

No provision is made for deferred taxation as no material timing differences are expected to reverse in the foreseeable future.

Leased assets and assets held under hire purchase agreement:
The fair value of an asset acquired under a finance lease or hire
purchase agreement is included in tangible fixed assets and depreciation
is provided in accordance with the company's accounting policy for the
class of asset concerned.

The interest cost is charged over the term of the agreement using a constant periodic rate of charge or method approximating thereto.

Rentals paid on operating leases are charged to the profit and loss account on a straight line basis over the term of the lease agreement.
