

THIS SECURITY ACCESSION DEED is made on 5 August 2014

BETWEEN

- **(1)** PAREX LTD, a company incorporated in England and Wales with registered number 2450579 (the New Chargor), and
- (2) BNP PARIBAS (the Security Agent) as agent and trustee for the Secured Parties (as defined in the Intercreditor Agreement)

RECITAL

This accession deed is supplemental to a debenture dated 13 June 2014 between, amongst others, the Chargors named therein and the Security Agent, as previously supplemented and amended by earlier Security Accession Deeds (if any) (the Debenture)

NOW THIS DEED WITNESSES as follows

1. INTERPRETATION

11 **Definitions**

Terms defined in the Debenture shall have the same meaning when used in this accession deed

12 Construction

Clause 1.2 (Construction) of the Debenture will be deemed to be set out in full in this accession deed, but as if references in such clause to the Debenture were references to this accession deed

2. ACCESSION OF NEW CHARGOR

2 1 Accession

The New Chargor agrees to be a Chargor for the purposes of the Debenture with immediate effect and agrees to be bound by all of the terms of the Debenture as if it had originally been a party to it as a Chargor

2.2 Covenant to pay

The New Chargor covenants to pay or discharge the Secured Liabilities in the manner provided for in the Secured Debt Documents

2.3 Specific Security

The New Chargor grants such security as is created by the Debenture, as if it had originally been a party to it as a Chargor, this includes security assets specified in the Schedule hereto, which supplements schedule 2 (Secured Assets) to the Debenture

3. CONSENT OF EXISTING CHARGORS

The existing Chargors agree to the terms of this accession deed and agree that its execution will in no way prejudice or affect the security granted by each of them under (and covenants given by each of them in) the Debenture

4. CONSTRUCTION OF DEBENTURE

The Debenture and this deed shall be read together as one instrument on the basis that references in the Debenture to "this Deed" will be deemed to include this accession deed

5. GOVERNING LAW

This deed (and any dispute, controversy, proceedings or claims of whatever nature arising out of or in any way relating to this deed or its formation) and obligations of the Parties hereto and any matter, claim or dispute arising out of or in connection with this deed (including any non-contractual claims arising out of or in association with it) shall be governed by and construed in accordance with English law
