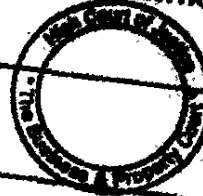

ORDER



UPON reading the application of Robin Hamilton Davis and John Anthony Dickinson dated 12 September 2018

AND UPON reading the Witness Statement of John Anthony Dickinson dated 11 September 2018 requesting that the proceedings listed above should be transferred to High Court of Justice, Business and Property Courts of England and Wales, Insolvency and Companies List for the purpose of replacing Carl James Bowles as office holder in respect of the companies with the applicants

IT IS ORDERED THAT:

Under Chapter 6 (Sub-division B) of Part 12 of the Insolvency (England and Wales) Rules 2016 (SI 2016/1024) that

- 1 The creditors' voluntary liquidations (CVL), compulsory liquidations (WUP), members' voluntary liquidations (MVL), administrations and bankruptcies listed in Schedules 1 to 5 (the Appointments Schedules) of this Order, which are the subject of proceedings in County Courts, or Hearing Centres, in England and Wales, be transferred to the High Court of Justice, Business and Property Courts of England and Wales, Insolvency and Companies List, solely for the purpose of making the order contained in paragraphs 2 to 16 below.

- 2 Immediately upon this order taking effect, the cases listed in the Appointments Schedules be transferred back to the relevant County Court or Hearing Centre.
- 3 That Carl James Bowles of Carter Backer Winter LLP (CBW), 66 Prescott Street, London E1 8NN (the Outgoing Office Holder) be removed from office as liquidator (voluntary or compulsory), administrator or trustee in bankruptcy (as the case may be) of the estates listed in the Appointments Schedules, from the date of this order.
- 4 That the Applicants be appointed as replacement Office Holders where they are listed as a new appointee in Appointments Schedules attached to this Order from the date of this order.
- 5 Where the appointments referred to in this Order are joint appointments, the functions of the Office Holders may be exercised by any or all of the persons appointed.
- 6 The Applicants shall give notice of this order to creditors of those estates listed in Schedules 1, 3, 4 and 5 which are listed as being in CVL, WUP, Administration and Bankruptcy and to members of those estates listed in Schedule 2 as being in MVL, by publishing one composite notice relating to the resignation and appointments as detailed in the Appointments Schedules in the London Gazette and must do so within 14 days of receipt of the sealed order.
- 7 Permission is given to the Secretary of State to apply to vary this Order at any time up to 28 days after the notices referred to in paragraph 6 above are published.
- 8 The Applicants shall notify the Secretary of State and the Registrar of Companies as soon as reasonably practicable of the making of this Order.
- 9 Service of the said Application and this Order on each of the companies listed in the Appointments Schedules attached to this order be dispensed with.
- 10 The Applicants shall file a copy of this Order with each of the County Courts listed in the attached Appointments Schedules.
- 11 There shall be liberty to each creditor of those estates listed in Schedules 1, 3, 4 and 5 as being in CVL, WUP, Administration and Bankruptcy and to each member of those estates listed in Schedule 2 as being in MVL, to apply to vary or discharge this Order insofar as it relates to the estate of which they are a member (in the case of MVL) or a creditor, as the case may be, within 21 days of the member or creditor (as the case may be) being given notice of this Order pursuant to paragraph 6. Such applications shall not affect the transfer of the block transfer cases listed in the Appointments Schedules until ordered by the court.
- 12 The costs of this Application (including VAT) shall be paid by CBW, without recourse, directly or indirectly to the estates listed in the Appointments Schedules of this order.
- 13 Subject to paragraph 12 above, in the event that, as a result of the implementation of the order CBW incurs any additional cost in respect of the administration of those estates where Carl James Bowles was the Office Holder (that is to say over and above those costs incurred in the ordinary course of the administration of those estates), those costs shall be borne by CBW and shall not be charged as an expense of the administration of those estates.
- 14 Without incurring any additional expense for any of the said estates, the relevant Applicant or Respondent shall notify each creditor of this application and this order by way of notice in the

next routine report that shall be due to the creditors of each estate, such notice to contain the following matters:

- 14.1 An explanation of the effect of the Order;
- 14.2 Express reference to the liberty to apply contained in paragraph 11;
- 14.3 In the case of Liquidations, where Liquidation Committees or Creditors' Committees have been appointed, an explanation that, to the extent that any information which would otherwise be required to be provided under Rule 6.25(5) or Rule 7.61(5) (as the case may be) of the Insolvency (England and Wales) Rules 2016 has not already been provided as part of the report, it is open to that committee to require the relevant Applicant or Respondents to provide an account of the administration of the estate, including a summary of receipts and payments, and a statement that he has reconciled his accounts;
- 14.4 In the case of Liquidations where no Liquidation Committees or Creditors' Committees have been appointed, an explanation that, to the extent that such information as aforesaid has not already been provided as part of the report, it is open to any creditor to apply to court for an order that the relevant Applicant or Respondents do provide an account of the administration of the estate, including a summary of receipts and payments, and a statement that he has reconciled his accounts;
- 14.5 Notification that if any Applicant or Respondent has been required to provide the information referred to in sub-paragraphs 14.3 and 14.4, whether by a Liquidation Committee or by court order on the application of any creditor(s), the costs of any appointed Office Holder of so complying will, unless there are good reasons to the contrary, be paid as an expense of the winding up or bankruptcy as the case may be;
- 14.6 In the case of Liquidations, notification to each creditor of his right under regulation 11(2) of the Insolvency Regulations 1994 to require the appointed Office Holders to supply a statement of receipts and payments free of charge; and
- 15 The Respondents shall, when the next routine report is due to the creditors of each appointment, give written notice of the making of this Order to each such creditor, such notice to include the following matters:
 - 15.1 An explanation as to the effect of the Order; and
 - 15.2 Express reference to the liberty to apply as set out in the Order.
- 16 The Respondents have the right to apply to the court to amend this Order to include any appointments held by the First Respondent which have been inadvertently omitted from the Application.
