AND UPON the Court considering that the order can be made without a hearing IT IS ORDERED THAT:

1. Each of the County Court cases listed in Schedules 1-5 attached to this order (**Schedules**) be transferred to the High Court of Justice, Business and Property Courts of England and

Wales, Insolvency and Companies List (Chancery Division) for the purpose only of making this order.

- 2. Immediately upon this order taking effect, the County Court cases listed in the Schedules be transferred back to the County Court.
- 3. Mark Peter George Roach (Outgoing Office-holder) be removed from office in respect of each of the cases listed in the Schedules (Block Transfer Cases) from the date of this order.
- 4. Where indicated against each case in the Schedules, Louise Adele Durkan, Mark Robin Sands, Brian Francis Burke or Graham David Randall (Replacement Office-holders) be appointed as joint Replacement Office-holders in respect of the Block Transfer Cases from the date of this order.
- 5. The removal of the Outgoing Office-holder and appointment of the Replacement Office-holders pursuant to paragraphs 3 and 4 above shall take place without the Outgoing Office-holder being required to (i) apply to the Secretary of State for release or discharge as appropriate pursuant to Section 173(2)(b), Section 174(4)(b) and Section 299 of the Insolvency Act 1986 as the case may be or (ii) file a receipts and payments account.
- 6. Where the cases referred to in the Schedules are joint appointments, any act required or authorised under any enactment to be done by joint appointees may be done by all or any one or more of the persons at the time being holding office.
