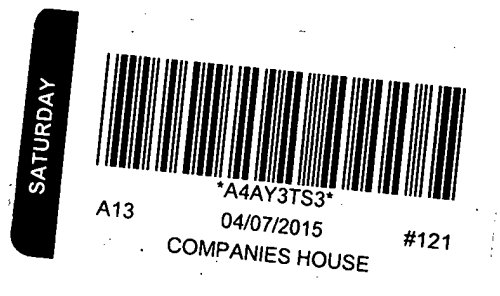

Business review


