UPON the application of Mr Andrew Little and Ms Kerry Pearson of Baldwins Restructuring and Insolvency, Wynyard Park House, Wynyard Avenue, Wynyard, Billingham, TS22 5TB ("Baldwins")

AND UPON READING the witness statement of Andrew Little dated 14 June 2017

AND UPON HEARING counsel for the Applicants, Miss Fiona Todd

AND UPON the First and Second Respondents consenting to this Order

IT IS ORDERED that:

1. The proceedings listed in Schedules 1a, 1b, 1c, 1d, 2 and 3 to this Order be transferred to the High Court of Justice, Chancery Division, Newcastle upon Tyne District Registry solely for the purpose of the determination and disposal of this Application upon which they will be transferred back to the court from which they were transferred.
2. Compliance with Rule 12.38(3) of the Insolvency (England and Wales) Rules 2016 is varied so that lodging of a certified copy of the sealed order herein with each Court is deemed to be compliant with that Rule.
3. The Applicants ensure that, pursuant to paragraph 2 above, a certified copy of this Order is filed with the court having jurisdiction over each case affected by the Order within 14 days of their receipt of the sealed order.

4. The time for service of the Application be abridged to 2 days.
5. From the date of this Order pursuant to Rule 12.37(1)(c) of the Insolvency (England and Wales) Rules 2016 ("the Rules") Peter Gray of Baldwins be removed as the sole office-holder in respect of each of the appointments listed in Schedule 1a to this Order and that pursuant to Rule 12.37(1)(d) of the Rules, Andrew Little and Kerry Pearson of Baldwins be appointed as joint office-holders (such appointment to be joint and several).
6. From the date of this Order pursuant to Rule 12.37(1)(c) of the Rules, Peter Gray be removed as joint office-holder of the appointment listed in Schedule 1b to this Order, that Gerald Krasner of Begbies Traynor Group Plc continue in office as joint office-holder and that pursuant to Rule 12.37(1)(d) of the Rules, Andrew Little be appointed as joint office-holder (such appointment to be joint and several).
7. From the date of this Order pursuant to Rule 12.37(1)(c) of the Rules, Peter Gray be removed as joint office-holder in respect of the appointments listed in Schedule 1c to this Order, that Andrew Little continue as joint office-holder and that pursuant to Rule 12.37(1)(d) of the Rules, Ms Kerry Pearson be appointed as joint office-holder (such appointment to be joint and several).
8. From the date of this Order pursuant to Rule 12.37(1)(c) of the Rules, Peter Gray be removed as joint office-holder in respect of the appointments listed in Schedule 1d to this Order, that Kerry Pearson continue as joint office-holder and that pursuant to Rule 12.37(1)(d) of the Rules, Andrew Little be appointed as joint office-holder (such appointment to be joint and several).
9. From the date of this Order pursuant to Rule 12.37(1)(c) of the Rules, Peter Gray be removed as joint office-holder in respect of the appointments listed in Schedule 2 to this Order, that Andrew Little continue as joint office-holder and that pursuant to Rule 12.37(1)(d) of the Rules, Ms Kerry Pearson be appointed as joint office-holder, (such appointment to be joint and several).
10. From the date of this Order pursuant to Rule 12.37(1)(c) of the Rules, Peter Gray be removed as joint office-holder in respect of the appointments listed in Schedule 3 to this Order, that Kerry Pearson continue as joint office-holder and that pursuant to Rule 12.37(1)(d) of the Rules, Andrew Little be appointed as joint office-holder (such appointment to be joint and several).
11. Peter Gray is not required to file any progress reports upon ceasing to act as office-holder pursuant to this Order.
12. Where relevant, the Applicants are obliged to produce and send further progress reports in accordance with the pre-existing reporting requirements of Peter Gray.
13. Notice of this Order shall be given by the Applicants to each creditor of each of the matters listed in the Schedules by advertisement in the London Gazette within 14 days of receipt of this Order by the Applicants and notice shall be given when next reporting to creditors in accordance with their statutory obligations.
14. Pursuant to paragraph 98 of Schedule B1 to the Act, Section 7(4) of the Act, Peter Gray be discharged from liability in respect of any action as administrator or supervisor of the companies and individuals listed in

- the Schedules, with effect from 28 days after the relevant notice referred to in paragraph 13 above has been advertised, save in respect of any claim notified to the Respondents or the Applicants by that date.
15. Pursuant to Rule 22 of Schedule 4 of the Rules and paragraph 22 to Part II of Schedule 4 of the Insolvent Partnerships Order 1994 and Section 263(4) of the Act, Peter Gray be at liberty to apply to the Secretary of State for his release as liquidator or trustee in bankruptcy of the companies, the partnership and individuals listed in the Schedules with effect from 28 days after the relevant notice referred to in paragraph 13 above has been advertised, save in respect of any Applicants by that date.
 16. The Applicants shall file any appropriate notices in respect of the removal of Peter Gray and the appointments of Andrew Little and Kerry Pearson pursuant to this Order with the Secretary of State for the Department of Business Innovation and Skills (the Insolvency Service) in accordance with Rule 12.38(6).
 17. There be liberty to each creditor of each matter listed in the Schedules to apply to vary or discharge this Order insofar as it relates to the estate of which they are a creditor within 28 days of their being given notice of it for the purposes of applying to vary or discharge the Order in so far as it affects the company or companies or individuals' estates of which they are a creditor.
 18. Peter Gray is not required to submit any reports in respect of any of the administrations and the voluntary liquidations listed in the Schedules as section 7A of the Company Directors Disqualification Act 1986 would otherwise require.
 19. This Order shall have no effect in respect of any of the matters in respect of which a certificate of completion is issued prior to the date upon which this Order becomes effective.
 20. The costs of the Application shall be met by Baldwins.
 21. The costs of implementing the Order (over and above those costs incurred in the ordinary course of administration of the cases listed in the Schedules) shall be borne by Baldwins Restructuring and Insolvency.
 22. Nothing contained in paragraph 20 or 21 shall prejudice the Applicants (or the Respondents) from:
 - a. charging to each appointment the cost of obtaining an Insolvency Practitioner's licence bond in respect of that appointment;
 - b. apportioning between the appointments equally the cost of the Gazette notice to be placed under paragraph 13 above; and
 - c. charging to each appointment, where applicable, the cost of altering the relevant HM Land Registry official register where a restriction has been placed against the individual or company's property.The sealed copy of this order is to be provided to the Applicant by the Court and the Applicant is to serve the Respondents with the order.
