The directors have pleasure in presenting their report together with the financial statements of the company for the year ended 24th March 2014.

1. **PRINCIPAL ACTIVITY**

The principal activity of the company continues to be as the manager of the properties 71, 72 and 73 Upper Berkeley Street and 12 Berkeley Mews, London W1. The company's activities are not operated with a view to profit.

2. **DIRECTORS**

Mr Y Tan, Ms J A Cooper and Mr P A Singer served as directors throughout the year.

Mr P A Singer resigned as a director on 23rd April 2014.

Messrs A Kaye, M Bokenham, D Levine and A Deepak were appointed as directors on 19th March 2014 and served for the rest of the year.

3. **STATEMENT OF DIRECTORS' RESPONSIBILITIES**

The directors are responsible for preparing the Annual Report and the financial statements in accordance with applicable law and regulations.

Company law requires the directors to prepare financial statements for each financial year and to be satisfied that the financial statements give a true and fair view.
