- 28 Creditors (and in the case of solvent liquidations, members) shall be given notice of this Order, and the provision for liberty to apply set out herein, by an advertisement in the London Gazette, placed by the substituted office holders referred to above by 3 December 2013
- 29 There shall be liberty to each creditor (or in the case of solvent liquidations, each member) to apply to vary or discharge this Order insofar as it relates to the estate of which they are a creditor (or member) within 28 days of being given notice of this Order
- 30 In respect of all the matters which are the subject of this Order, there shall be no requirement for progress reports or receipts and payment accounts to be prepared and served or filed by virtue of Neil Francis Hickling vacating office in accordance with this Order. The provisions of Rules 2 47(3A), 6 78A(4), 4 49B(5) and 4 49C-CLV(3)(a) of the Rules shall not apply in respect of the matters which are the subject of this Order
- 31 The period covered by subsequent progress reports shall be the relevant date for which progress reports would have been prepared but for Neil Francis Hickling vacating office by virtue of this Order
- 32 The costs of this application shall be borne by Smith & Williamson LLP.
