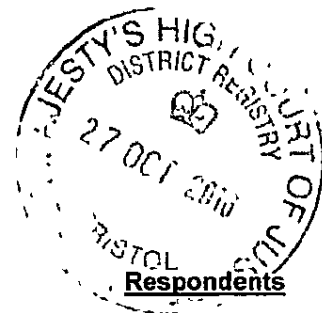

IT IS ORDERED THAT

- 1 Pursuant to Rule 7 10C(1) of the Insolvency Rules 1986 ("the Rules") any of the matters listed in the schedules attached to this Order which are proceeding in any court other than the High Court are transferred to the High Court (Bristol District Registry) solely for the purposes of this Order and thereafter are transferred back to the original court

- 17 In respect of all the matters which are the subject of this Order, there shall be no requirement for progress reports or receipts and payment accounts to be prepared and served or filed by virtue of Paul David Wood vacating office in accordance with this Order. The provisions of Rules 2.47(3A), 6.78A(4), 4.49B(5) and 4.49C-CVL(3)(a) of the Rules shall not apply in respect of the matters which are the subject of this Order
- 18 The period covered by subsequent progress reports shall be the relevant date for which progress reports would have been prepared but for Paul David Wood vacating office by virtue of this Order
- 19 The costs of this application shall be borne by Smith & Williamson LLP
