The Company is a holding company and has no employees

The Company has provided a loan to its immediate parent company, De La Rue Holdings plc. The principal risk to the Company is the risk of default on this loan.

Review of business and future developments

The Company will continue to operate in accordance with its principal activities for the immediate future

The Company received no dividends from subsidiary undertakings during the period (2010 £nil)

The Company and certain other De La Rue Group companies utilise a £175 million three and a half year revolving facility which expires in September 2013. Key financial covenants on this facility are unchanged

Key performance indicators

The Directors monitor and manage the performance of each investment against its published financial statements and against the key performance indicators (KPI's) of the De La Rue Group because the Company's Directors believe that analysis using KPI's specifically for the Company is not necessary or appropriate for an understanding of the development, performance or position of the business. Details of the Group's KPI's, which includes the Company are set out in the Business Review section on pages 4 – 31 of the annual report of De La Rue plc, which does not form part of this report

Results and dividends

The profit for the period after taxation was £601,000 (2010 £1,432,000 loss) The Directors do not recommend the payment of a dividend (2010 £nil) The profit for the financial period of £601,000 (2009 £1,432,000 loss) has been transferred to reserves

Notes to the Financial Statements

1 Accounting policies

(a) Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards. The accounts have been prepared as at 26 March 2011, being the last Saturday in March. The comparatives for the 2010 financial period are for the period ended 27 March 2010.

The Company has considerable net assets. As a consequence, after consideration of the credit risk of the loan made to its immediate parent company, the Directors believe that the Company is well placed to manage its business risks successfully

The Directors have a reasonable expectation that the Company has adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis of accounting in preparing the annual financial statements.

(b) Consolidation of subsidiaries

The financial statements contain information about De La Rue Investments Limited as an individual Company and do not contain consolidated financial information as the parent of a group of companies. The Company is exempt under section 400 of the Companies Act 2006 from the requirement to prepare consolidated financial statements as it and its subsidiary undertakings are included by full consolidation in the consolidated financial statements of its ultimate parent, De La Rue plc, a company registered in England and Wales. References to "Group" mean to De La Rue plc and its subsidiaries.

(c) Foreign Currencies

Transactions in foreign currencies are recorded using the rate of exchange ruling at the date of the transaction. Exchange gains and losses on monetary assets and liabilities are dealt with in the profit and loss account, except to the extent that they represent a hedge of the Company's overseas investments, which are dealt with in reserves together with the exchange differences on the carrying value of the related investment.

(d) Interest

Interest is recognised in the profit and loss on an accruals basis

(e) Taxation

The charge for taxation is based on the profit for the period and takes into account taxation deferred because of timing differences between the treatment of certain items for taxation and accounting purposes. Deferred tax is recognised, without discounting, in respect of all timing differences between the treatment of certain items for taxation and accounting purposes which have arisen but not reversed by the balance sheet date, except as otherwise required by FRS 19

(f) Investments

Investments are stated at cost or valuation in the balance sheet, less provision for any impairment in the value of the investment

2 Directors' emoluments and auditors' remuneration

The Directors and all other staff engaged on the Company's operations received no fees or other remuneration from the Company (2010 Nil) During the period under review Mr S C Webb (resigned 1 June 2010) and Mr C C Child (appointed 1 June 2010) were employed by De La Rue plc, and Mr E H D Peppiatt was employed by De La Rue Holdings plc, and all were remunerated in respect of their services to the Group as a whole by his or her employing company Their emoluments are dealt with in those companies' financial statements. There are no persons employed by the Company (2010 Nil). The auditors' remuneration was borne by another Group company.
