

#### **8 Contingent liabilities and transactions with directors**

There are no contingent liabilities apart from the company's day to day obligation to maintain the common parts of 40 Limes Grove. Expenditure so incurred is recoverable from the lessees, including the directors, under the terms of their lease. An amount of £3,449 (2010 - £3,449) is owed to the shareholders, including the directors, being amounts loaned to the company on an interest free basis.

#### **9 Auditors' Ethical Standards**

#### **10 Related party transactions**
