- 1. The Joint Administrators' proposals as set out at paragraphs 9.1 to 9.5 of the report dated 31 May 2019 are approved.
- 2. In the event that a Creditors' Committee is not established, the Joint Administrators be discharged from liability in respect of any action of theirs as Joint Administrators immediately following their cessation to act as Joint Administrators.
- 3. In the event that a Creditors' Committee is not established, then in accordance with the fee estimate provided to creditors on 31 May 2019 at Appendix K to these proposals the Joint Administrators shall be authorised to draw their remuneration based upon time costs limited to the sum of £160,046 (plus VAT).
- 4.
