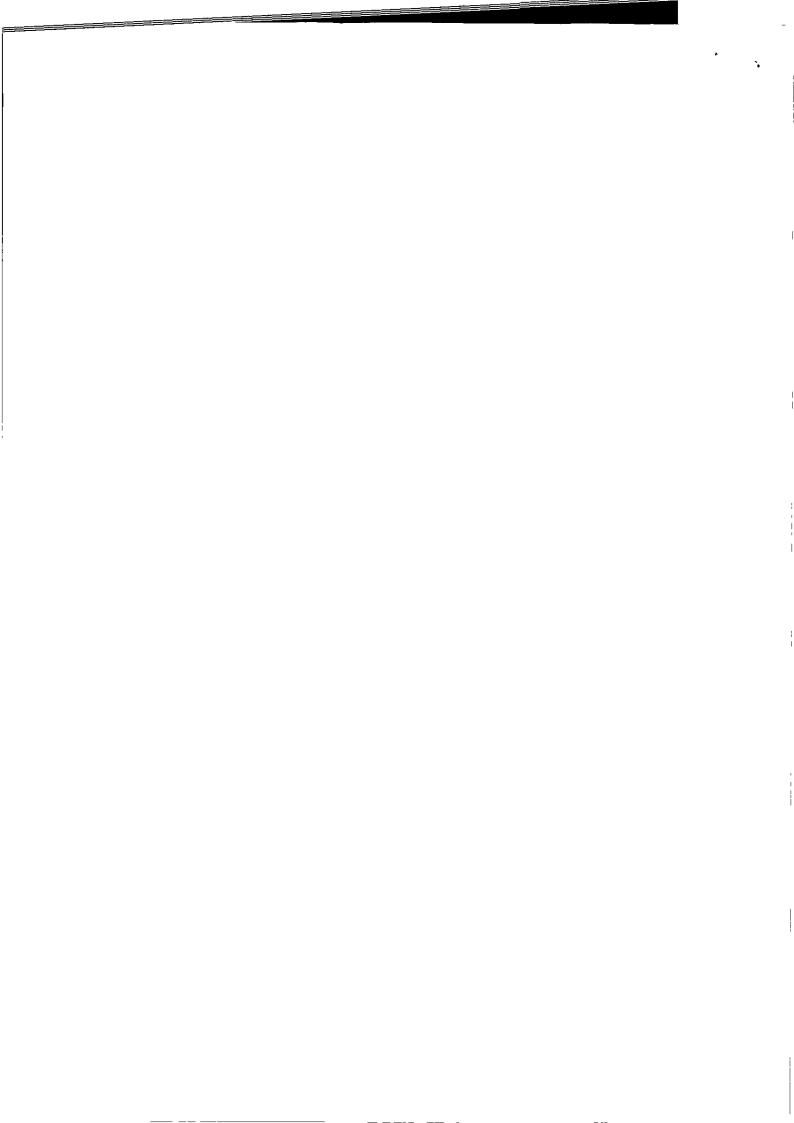

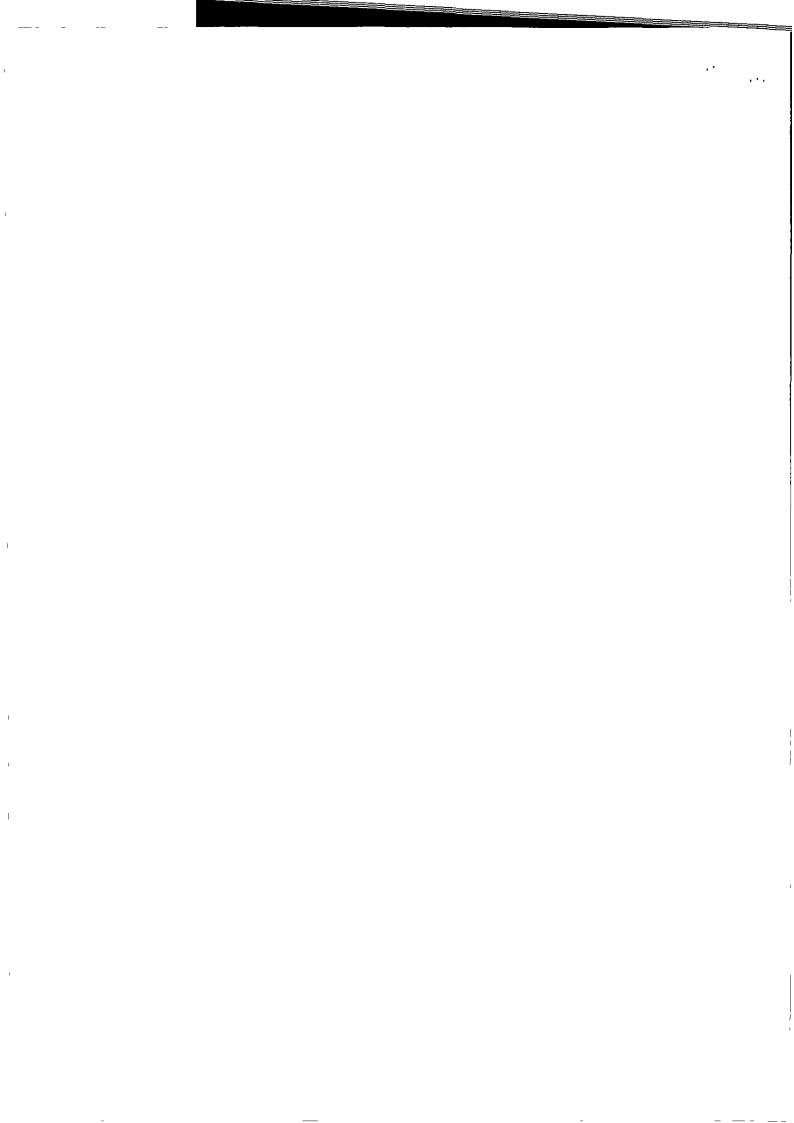

ASSETS/RECEIPTS

Assets declared in the Statement of Affairs are explained as follows



Motor Vehicles

The Director's sworn Statement of Affairs listed 6 minibuses with an estimated to realise sum of £6,000

Following the appointment of the Joint Liquidators', Agentcite valued the vehicles with a collective value of £4,750 if purchased by a willing buyer or £1,950 in a forced sale

My agent advised me that two vehicles were in fair condition, three were in very poor condition and should be scrapped and the final vehicle was subject to a finance agreement with Blackhorse Finance Limited

The vehicles were either sold or scrapped and £4,545 18 was realised. The realisations have been broken down as follows

- Vehicle Reg EY54FNA realised £3,000 on 07/06/2011 This vehicle was sold to Abba Day
 Care Centre who contacted me directly when making the offer Agentcite however confirmed
 that the offer was fair and reasonable
- Vehicle Reg Y915GKK realised £500 plus VAT by Agentcite
- Three vehicles scrapped realised £416 67 plus VAT by Agentcite
- Vehicle subject to finance agreement, surplus funds received £628 51

Please note that £628 51 was realised representing surplus funds after Blackhorse Finance Limited sold the vehicle subject to finance and set the funds off against the debt due to them

Further to the above, upon my agent's initial inspection, he established that there were assorted items of vehicle spare parts including light bulbs and fuses but were unavailable for inspection. Those items were declared by the Director onsite but informed my agent that they were locked away in a store cupboard within the building which had been re-possessed by the council.

As a result, my agent formed the view that the items did not have a marketable value and no further action was taken

Book Debts

The Director's sworn Statement of Affairs listed book debts with an estimated to realise sum of £14,481 48

Immediately following my appointment, I instructed an agent PJM Insolvency Debt Collection Service to collect the book debts

A total of £8,168 32 has been realised All book debts have now been collected and my agents services have effectively come to an end

Cash at Bank

The Director's sworn Statement of Affairs listed cash at bank with an estimated to realise sum of £3,000

Following my appointment, £3,077 76, representing the remaining balance, was realised on 6 January 2011 for the benefit of the liquidation estate. The company account was then closed

Monies held at Solicitors

The Director's sworn Statement of Affairs showed the company's solicitor held funds totalling £3,530

Upon my appointment, it was established that the company approached Kaslers Solicitors for advice regarding their financial difficulties and the process of winding up the company

The company made an initial payment of £4,000 to the solicitors from which they drew £470 in respect of their fees. The remaining balance of £3,530, held on their client account, was paid directly to me for



the benefit of the estate on 19 January 2011

Third Party Insurance Payment

A vehicle was destroyed by a fire which was owned by Abba Day Care Centre, a partner organisation, which was insured by Newham Community Transport

The insurance company paid out £3,750 which was subsequently paid to Abba Day Care Centre

Bank Interest Gross

Bank interest of £23 90 has been received on the credit balance in the liquidation bank account

PAYMENTS

Statutory Advertising

£84 60 plus VAT has been paid to Courts Advertising Limited in respect of the advertising of the final meetings of members and creditors

Preparation of Statement of Affairs

Prior to Liquidation, the Directors agreed to pay a fee of £5,000 plus VAT and disbursements to for convening the meetings of members and creditors to place the company into liquidation and assisting in the preparation of the Statement of Affairs Creditors confirmed their approval of this fee at the meetings held on 15 November 2010

This fee has been paid in full

Specific Bond

For the period of this report, AUA Insolvency Risk Services Limited has been paid £139 in respect of statutory bonding

Insurance

For the period of this report, Willis Limited has been paid £49 in respect of insurance of the company's tangible assets

Insurance Refund

This represents the insurance refund paid to Abba Day Care Centre referred to above

Premises Clearance

£200 was paid to G&B Compressed Hire Limited who cleared the Company's premises

Agents/Valuers Fees

£1,042 plus VAT has been paid to Agentcite who were instructed to deal with the sale of the Company motor vehicles

Debt Recovery Costs

£371 78 plus VAT has been paid to PJM Insolvency Debt Collection Service who was instructed to collect in the book debts

Storage costs

For the period of this report, Total Data Management Limited has been paid £109 78 in respect of

statutory storage of the company books and records

Joint Liquidators' Remuneration

To date, I have drawn remuneration totalling £11,111 60 plus VAT. This is explained in more detail under the section headed Joint Liquidators' Remuneration.

Joint Liquidators' Expenses

Expenses totalling £286 80 have been incurred since my appointment. Those expenses are explained in more detail under the heading Joint Liquidators' Expenses.

LIABILITIES

Secured Liabilities

A search of the register held by the Registrar of Companies showed that the company has given no charges

The Statement of Affairs did not record any secured liabilities. As a result, prescribed part is not applicable

Preferential Creditors

The Statement of Affairs recorded preferential creditors in respect of employee matters with an uncertain amount due

Throughout the liquidation, claims have been received and forwarded onto the Redundancy Payments Office who have paid out £29,635 30

Crown Creditors

The Statement of Affairs did not record any liability due to HM Revenue & Customs

However, I have received a claim from Inland Revenue totalling £12,152 62 in respect of TAX PAYE underpayment and NIC PAYE underpayment

Unsecured Creditors

The Statement of Affairs included 33 unsecured creditors with an estimated total liability of £97,140 63

I have received claims from 11 creditors at a total of £75,289 30

DIVIDENDS

A dividend has not been paid to unsecured creditors in this liquidation as the funds realised have been used to meet the expenses of the liquidation

INVESTIGATION INTO THE AFFAIRS OF THE COMPANY

The Joint Liquidators' took steps to realise the cash at bank and vehicles immediately upon appointment

It was extremely difficult to secure the vehicles as they were stored at the company's old premises which had been repossessed by the local council who had started construction to the road and pavement which was located directly outside the main access to the site

A considerable amount of time was spent liaising with the local council to allow us access to the site to value the vehicles along with interested purchasers

It was then established that there was no suitable way of removing the vehicles from site as the access road had been dug up. Therefore, many months passed waiting for road to be made-good or establish a safe way of removing the vehicles. Those negotiations were made directly with the local council.

The Joint Liquidators' instructed an agent to value and sell the vehicles and also assist with the above issues which arose

Investigations were made into the payment which the company paid to Kaslers Solicitors for advice. After establishing that they were holding company funds in their client account it was requested that they were transferred to the liquidation account.

The Joint Liquidators' instructed an agent to realise the book debts of the company and realisations of those book debts

A considerable amount of time has been spent liaising with Mr Peter Mico regarding the remaining book debts

After a number of attempts trying to secure funds from the remaining debtors, it appeared that only one debtor was not responding

Due to the minimal value due, it did not appear commercially worthwhile to pursue this debtor through the courts and therefore formed the view that no further action should be taken

JOINT LIQUIDATORS' ACTIONS SINCE APPOINTMENT

Following the appointment of the Joint Liquidators investigations into the Company's affairs have been undertaken to establish whether there were any potential asset recoveries or conduct matters that justified further investigation, taking account of the public interest, potential recoveries, the funds likely to be available to fund an investigation, and the costs involved

There were no matters that justified further investigation in the circumstances of this appointment

Within six months of our appointment, the Joint Liquidators' are required to submit a confidential report to the Secretary of State to include any matters which have come to our attention during the course of our work which may indicate that the conduct of any past or present director would make he/she unfit to be a concerned with the management of the company. We confirm that this report has been submitted

PRE-APPOINTMENT REMUNERATION

The board previously authorised the payment of a fee of £5,000 plus VAT and disbursements plus VAT for providing assistance with the preparation of the Statement of Affairs prior to our appointment at a meeting held on 20 October 2010. The fee was duly sanctioned by creditors at the meeting held on 15 November 2010.

The fee for the assistance in preparing the Statement of Affairs and convening the relevant meetings was paid from first realisations on appointment and is shown in the enclosed receipts and payments accounts

JOINT LIQUIDATORS' REMUNERATION

My remuneration was previously authorised by creditors at a meeting held on 15th November 2011 to be drawn on a time cost basis. My total time costs to 15th January 2014 amount to £28,603 70 representing 172 88 hours work at an average charge out rate of £165 45 per hour.

I have drawn £11,111 60 in remuneration

A schedule of my time costs incurred to date is attached
