

**3 Profit and loss account**

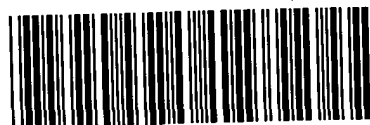
The company has not traded during the period and accordingly has made neither a profit nor a loss. No profit and loss account has therefore been prepared.
