**BEFORE DISTRICT JUDGE PEMA ON 7 JANUARY 2021 sitting at The Business and Property Courts in Leeds, The Courthouse, 1 Oxford Row, Leeds, LS1 3BG.**

**UPON the Application for a block transfer order dated 25 November 2020**

**AND UPON READING the evidence filed**

**IT IS ORDERED THAT:**

1. Each of the High Court cases listed in the Schedules (attached to this Order) (the **Block Transfer Cases**) be transferred to the High Court of Justice, Chancery Division, Business and Property Courts in Leeds for the purpose only of making this Order.
2. Immediately upon this Order taking effect, the **Block Transfer Cases** be transferred back to their original location of High Court.
3. Jeremy Woodside (the **Outgoing Officeholder**) be removed from office in respect of each of the **Block Transfer Cases** from the date of this Order pursuant to Rule 12.37(2) of the Rules without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Rules for the insolvency cases listed in the Schedule (ii) apply to the Secretary of State for release or discharge pursuant to the Insolvency Act 1986 or (iii) file a receipts and payments account.
4. Lindsey Jane Cooper, Christopher Ratten and Keith Jeffery Algie (the **Replacement Officeholders**) be appointed as replacement officeholders in respect of each of the **Block Transfer Cases** as listed in the Schedules (attached to this Order) from the date of this Order pursuant to Rule 12.37(3) of the Rules without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Rules for the **Block Transfer Cases** (ii) apply to the Secretary of State for release or discharge pursuant to the Insolvency Act 1986 or (iii) file a receipts and payments account.
5. The creditors in each of the **Block Transfer Cases** be notified of this Order by way of one composite advertisement published in the London Gazette (the **Advertisement**) within 14 days of receipt of the sealed Order from the Court and at the time of the next statutory reporting required for each of the **Block Transfer Cases**. Creditors of the Company Voluntary Arrangement listed in Schedule 1 (attached to this Order) shall be notified in writing of this order within 14 days of receipt of the sealed order.
6. Any creditor in respect of any of the companies or persons listed in the **Block Transfer Cases** who has an objection to this Order shall have 28 days from the date of the **Advertisement**, or date of deemed receipt of written notification, referred to at paragraph 5 to apply to Court to

set aside or vary the terms of this Order. Such application shall not affect the transfer of the Block Transfer Cases until further or other Order by the Court.

7. In the case of the Administrations listed in Schedules 1 and 2 (attached to this Order), the Outgoing Officeholder be released forthwith from any and all liability past, present or future in respect of any act(s) and/or omissions in relation to his conduct as Outgoing Officeholder of the estates. Such release to take effect 28 days from the date of the Advertisement, save in respect of any claim notified to the Applicant pursuant to the Insolvency Act 1986 and/pursuant to such other provision as may apply on or prior to the notice date.
8. The Replacement Officeholders shall give notice to the Secretary of State (Insolvency Service), of the terms of this Order as soon as reasonably practicable.
9. The Outgoing Officeholder shall file a copy of this Order with each of the Courts listed in the Schedules (attached to this Order) where applicable.
10. Nothing in this Order shall release the Outgoing Officeholder from any obligation to give and file notices in respect of his removal under this Order in respect of the Block Transfer Cases.
11. The Outgoing Officeholder shall receive his release as Liquidator, Supervisor or Administrator (as appropriate) 28 days after giving of notice to creditors in accordance with this Order in accordance with paragraph 5, save that such release may be subject to further Order in the event of an application by any creditor or member under paragraph 6 of this Order for the specific case subject to that application.
12. For the Administration cases, set out in Schedules 1 and 2 (attached to this Order), where Jeremy Woodside is removed and replaced as Administrator and those administrations are subsequently converted into Creditors' Voluntary Liquidations, Lindsey Jane Cooper or Christopher Ratten, shall also replace Jeremy Woodside as Liquidator.
13. Where there are joint office holders appointed on the Block Transfer Cases, they will act jointly and severally in relation to all matters relating to the administration of the Block Transfer Cases.
14. The parties have liberty to apply to the court to amend this Order to include any appointments held by the First Applicant which have been inadvertently omitted from the Application.

15. The terms of the order shall not apply to any case which is listed in the Block Transfer Cases.

16. Such further order or other relief or direction as the court shall deem fit.

17. The costs of the Application (including VAT) shall be met by RSM Restructuring Advisory LLP.
