- 4. Lindsey Jane Cooper, Christopher Ratten and Keith Jeffery Algie (the Replacement Officeholders) be appointed as replacement officeholders in respect of each of the Block Transfer Cases as listed in the Schedules (attached to this Order) from the date of this Order pursuant to Rule 12.37(3) of the Rules without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Rules for the Block Transfer Cases (ii) apply to the Secretary of State for release or discharge pursuant to the Insolvency Act 1986 or (iii) file a receipts and payments account.
- 5. The creditors in each of the Block Transfer Cases be notified of this Order by way of one composite advertisement published in the London Gazette (the Advertisement) within 14 days of receipt of the sealed Order from the Court and at the time of the next statutory reporting required for each of the Block Transfer Cases. - 6. Any creditor in respect of any of the companies or persons listed in the Block Transfer Cases who has an objection to this Order shall have 28 days from the date of the Advertisement, or date of deemed receipt of written notification, referred to at paragraph 5 to apply to Court to
