I refer to my appointment as liquidator of the above and hereby submit my final report regarding my administration of the liquidation in accordance with the Insolvency Act 1986 and Insolvency Rules

### **Background**

The company traded satisfactorily and provided services until the Directors were advised to enter into a members voluntary liquidation

Accounts were prepared by the company accountants and filed at companies house

### **DETAILS OF PROGRESS DURING THE LIQUIDATION**

I confirm that all work and investigations necessary for the satisfactory winding up of the Company has been completed

This was a consultancy business and the directors have sworn a declaration of solvency

I have not carried out any detailed investigation into the books and records of the Company

All statutory returns to Companies House have been made and statutory advertising done Reports and records have been completed in compliance with the Insolvency Act and Rules

Monies were all invested in a designated deposit account and kept separately from all other monies before being paid to the members
