1. Accounting policies

Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with United Kingdom Accounting Standards and applicable company law.

The company meets the definition of a qualifying entity under FRS 100 (Financial Reporting Standard 100) and so the financial statements have been prepared in accordance with FRS 101 'Reduced Disclosure Framework'. As such the recognition and measurement requirements of EU-adopted IFRS have been applied, with amendments where necessary in order to comply with Companies Act 2006 and The Small Companies and Groups (Accounts and Directors' Report) Regulations 2008 as these are Companies Act 2006 accounts.

The company did not trade during the current or prior year, and accordingly neither a profit nor a loss has been made. Consequently, no income statement, statement of changes in equity or cash flow statement has been presented.

The financial statements are presented in sterling and all values are rounded to the nearest pound except when otherwise indicated.

Going concern

The company has net assets of nil. On this basis, the directors believe it is appropriate to prepare the accounts on a going concern basis.

Exemption from preparing group financial statements

The financial statements contain information about UU Group Limited as an individual company and do not contain consolidated financial information as a parent of a group. At 31 March 2021, the company was exempt under section 400 of the Companies Act 2006 from the requirement to prepare consolidated financial statements as it and its subsidiary undertaking were included by full consolidation in the financial statements of its ultimate parent United Utilities Group PLC, a company incorporated and registered in England and Wales.

2. Operating profit

There have been no employees of the company during the year, other than the directors (2020: nil, other than the directors).

The company was not subject to an audit in either year and there were no non-audit services provided by the auditor to the company in either year.
