REPORT OF THE DIRECTORS

The directors present herewith their report, together with the audited financial statements of the company for the year to 30 April 2003.

PRINCIPAL ACTIVITY

The company is a holding company, the business of the group being property investment.

REVIEW OF THE BUSINESS AND FUTURE DEVELOPMENTS

The combined net assets of the company's two subsidiaries has increased to £2,175,628. Details of the company's subsidiaries, including their performance for the year, are set out in note 4. The group intends to develop its principal activity.

DIVIDENDS

The company received a dividend of £63,000 from its subsidiary undertaking, Incomegain Limited (2002 £27,076) The company declared and paid a first and second interim dividend each of 6.4285714 pence per share in respect of the year to 30 April 2003, totalling £63,000. (2002 £25,210).

The directors do not recommend payment of a final dividend.

RESULTS AND TRANSFER TO RESERVES

Any change in the company's share of the underlying net assets of its subsidiary companies is credited to an unrealised capital reserve.

a) Accounting conventions

Investments held as fixed assets are stated at the company's share of the underlying net assets of the investments less provision for any permanent diminution in value. any surplus or deficit arising on valuation is transferred to the unrealised revaluation reserve.

d) Basis of consolidation

Group financial statements have not been prepared as the group qualifies as a small group under Section 248 of the Companies Act 1985.
