

ORDER

---

UPON THE APPLICATION of the Applicants

AND UPON HEARING Counsel for the Applicants and Counsel for the Secretary of State

AND UPON READING a draft originating application and a draft affidavit with exhibit of the second-named Applicant, Geoffrey Robbins

AND UPON the Applicants by their Counsel undertaking as soon as practicable to issue an originating application and file a sworn affidavit with exhibit substantially in the form of the aforementioned draft

IT IS ORDERED

1. That such of the insolvency proceedings listed in the Schedule marked "A" attached to this Order as are proceeding in any Court other than the High Court in London be transferred to the High Court in London for the purposes of this Application and be re-transferred forthwith on the making of this Order, save for any application made pursuant to the leave given in paragraph 14 below.
2. That the first-named Applicant, Neil Charles Money (hereinafter referred to as "Neil Charles Money") be appointed Liquidator as from 9<sup>th</sup> September 1999 of all the Companies in Creditors Voluntary Liquidation listed in Part I of the Schedule marked "A" attached to this Order (or Joint Liquidator with another as the case may be) where his initials appear in column 5 in place of the Respondent, David Nisbet (hereinafter referred to as "David Nisbet").

3. That the second-named Applicant, Geoffrey Robbins (hereinafter referred to as "Geoffrey Robbins") be appointed Liquidator as from 9<sup>th</sup> September 1999 of all the Companies in Creditors Voluntary Liquidation listed in Part I of the Schedule marked "A" attached to this Order (or Joint Liquidator with another as the case may be) where his initials appear in column 5 in place of David Nisbet.
4. That Neil Charles Money be appointed Liquidator as from 9<sup>th</sup> September 1999 of all the Companies in Members Voluntary Liquidation listed in Part II of the Schedule marked "A" attached to this Order (or Joint Liquidator with another as the case may be) where his initials appear in column 5 in place of David Nisbet.
5. That Geoffrey Robbins be appointed Liquidator as from 9<sup>th</sup> September 1999 of the Company in Members Voluntary Liquidation listed in Part II of the Schedule marked "A" attached to this Order (or Joint Liquidator with another as the case may be) where his initials appear in column 5 in place of David Nisbet.
6. That Neil Charles Money be appointed Liquidator as from 9<sup>th</sup> September 1999 of all the Companies in Compulsory Liquidation listed in Part III of the Schedule marked "A" attached to this Order (or Joint Liquidator with another as the case may be) where his initials appear in column 5 in place of David Nisbet.
7. That Geoffrey Robbins be appointed Liquidator as from 9<sup>th</sup> September 1999 of all the Companies in Compulsory Liquidation listed in Part III of the Schedule marked "A" attached to this Order (or Joint Liquidator with another as the case may be) where his initials appear in column 5 in place of David Nisbet.
8. That Neil Charles Money be appointed Supervisor as from 9<sup>th</sup> September 1999 in relation to the voluntary arrangements of all the Companies listed in Part IV of the Schedule marked "A" attached to this Order (or Joint Supervisor with another as the case may be) where his initials appear in column 5 in place of David Nisbet.
9. That Geoffrey Robbins be appointed Supervisor as from 9<sup>th</sup> September 1999 in relation to the voluntary arrangements of all the Companies listed in Part IV of the Schedule marked "A" attached to this Order (or Joint Supervisor with another as the case may be) where his initials appear in column 5 in place of David Nisbet.
10. That Geoffrey Robbins be appointed Provisional Liquidator as from 9<sup>th</sup> September 1999 of the Companies listed in Part V of the Schedule marked "A" attached to this Order in place of David Nisbet.
11. That Neil Charles Money be appointed Administrator as from 9<sup>th</sup> September 1999 of all the Companies in administration listed in Part VI of the Schedule marked "A" attached to this Order (or Joint Administrator with another as the case may be) where his initials appear in column 5 in place of David Nisbet.
12. That Geoffrey Robbins be appointed Administrator as from 9<sup>th</sup> September 1999 of all the Companies in administration listed in Part VI of the Schedule marked "A" attached to this Order (or Joint Supervisor with another as the case may be) where his initials appear in column 5 in place of David Nisbet.
13. That the Applicants' costs of this Application be divided in equal proportions between all the insolvency proceedings listed in the attached Schedule marked "A" save that in no one case should the costs (including VAT) exceed 10% of the realisable assets.
14. That there be general liberty to apply.
