


CHESHIRE MORTGAGE CORPORATION LIMITED (Company)

- 2 That, notwithstanding any provisions of the Company's Memorandum and Articles of Association or any personal interest of any of the Company's directors, the Company's directors and/or secretary be and are hereby authorised and directed to execute, deliver and perform the obligations set out in the Document and give or execute any or all notices, communications or other documents on behalf of the Company pursuant to or in connection with the Document for the Company (in such manner and subject to such changes as the Company's directors, in their absolute discretion, think fit (such opinion being evidenced by the execution of such Document, notices, communications or other documents)).
