ORDER

UPON THE APPLICATION of Jonathan David Law ('Mr Law') and John Christopher

Sallabank ('Mr Sallabank') of Harrisons Business Recovery and Insolvency Limited of 35

Waters Edge Business Park, Modwen Road, Manchester, M5 3EZ under the Insolvency Act 1986 (the 'Act') and Insolvency Rules 1986 (the 'Rules') Mr Law being variously the Trustee in Bankruptcy and Supervisor of the Bankruptcies and Voluntary Arrangements referred to in the schedule annexed hereto and, jointly with Mr Sallabank, the Liquidator and Administrator of the Liquidations and Administrations referred to in the schedule annexed hereto (hereinafter referred to as the "Schedule" and which shall form part of this Order) by Application Notice dated 15 June 2012

UPON READING THE DOCUMENTS recorded on the Court file as having been read IT IS ORDERED that

Service of Application and Transfer

- Further service of this Application Notice and evidence upon any party be dispensed with and, to the extent required, time for service be abridged
- The proceedings identified in italics in Part A of the Schedule together with the proceedings referred to in Parts B, D and F be transferred to the High Court pursuant to rule 7 10D(2) of the Insolvency Rules 1986 ('the Rules') for the purpose only of considering and making the orders contained at paragraphs 4 to 20 of this Order
- 3. Upon the making of the orders at paragraphs 4 to 20 of this Order herein the insolvency proceedings transferred by paragraph 2 shall be automatically re-transferred to the relevant County Court

Liquidation Appointments

4 Mr Law be removed as Liquidator of the companies referred to in Part A of the Schedule

pursuant to section 172 (2) of the Act and Rule 7.10B(2) of the Rules

- 5. Douglas Paul Glenn Walker of Harrisons Business Recovery and Insolvency Limited of 35 Waters Edge Business Park, Modwen Road, Manchester, M5 3EZ ('Mr Walker') be appointed as Liquidator of those companies and the partnership referred to at Part A of the Schedule pursuant to section 168(3) of the Act and rule 7.10B(2) of the Rules
- 6 Mr Law be removed as Joint Liquidator of the companies referred to in Sections 1 and 2 of Part B of the Schedule pursuant to section 108 of the Act
- 7 Mr Walker be appointed as Joint Liquidator of the companies referred to in Section 2 of Part B to the Schedule pursuant to section 108 of the Act
- 8. Mr Law be removed as Joint Liquidator of the limited liability partnership referred to in Section 3 of Part B of the Schedule pursuant to section 108 of the Act (applied by virtue of paragraph 5 of the Limited Liability Partnership Regulations 2001)
- 9. Mr Walker be appointed as Joint Liquidator of the limited liability partnership referred to in Sections 2 and 3 of Part B to the Schedule pursuant to section 108 of the Act (applied by virtue of paragraph 5 of the Limited Liability Partnership Regulations 2001)

10. Mr Law be removed as Joint Administrator of the companies referred to at Part C of the Schedule pursuant to paragraph 88 of Schedule B1 of the Act and rule 7 10B(2) of the Rules

- Mr Law shall be discharged from hability in respect of those cases referred to in Part C of the Schedule pursuant to paragraph 98(1) of Schedule B1 to the Act on the date of this Order

- 14. Mr Walker be appointed as Trustee in Bankruptcy of the individuals referred to in Section 1 of Part D of the Schedule pursuant to sections 298 and 303(2) of the Act and rule 7.10B(2) of the Rules
- 15. Mr Sallabank be appointed as Trustee in Bankruptcy of the individuals referred to in Section 2 of Part D of the Schedule pursuant to sections 298 and 303(2) of the Act and rule 7.10B(2) of the Rules

Voluntary Arrangements

16. Mr Law be removed as Supervisor of the companies referred to at Part E of the Schedule pursuant to section 7(5) of the Act

- Mr Walker be appointed as Supervisor of the companies referred to at Part E of the Schedule pursuant to section 7(5) of the Act
- 18. Mr Law be removed as Supervisor of the individuals listed in Part F of the Schedule pursuant to section 263(5) of the Act
- 19 Mr Walker be appointed as Supervisor of the individuals referred to at Section 1 of Part F to the Schedule pursuant to section 236(5) of the Act
- 20. Mr Sallabank be appointed as Supervisor of the individuals referred to at Section 2 of Part
 F to the Schedule pursuant to section 236(5) of the Act

Service, filing and advertisement, joint and several acts

- 21. The removal of Mr Law and the appointment of Mr Walker and Mr Sallabank

 pursuant to paragraphs 4 to 20 of this Order together with the terms of this Order shall

 be notified by Mr Walker and Mr Sallabank to.
 - (1) the companies and individuals referred to in the Schedule and the creditors of those companies and individuals by way of advertisement of this Order and the Schedule in the London Gazette within seven business days of the date of sealing of this Order
 - (2) The Secretary of State as soon as reasonably practicable
- 22 Mr Law shall cause sealed copies of this Order to be sent to the Courts having jurisdiction over the cases set out in the Schedule for lodgment on the Court file relating to that case

- 23. Further service, filing or advertisement of the Application Notice, this Order and its terms (including, for the avoidance of doubt, the removals from and appointments to office effected under the Order) and any supporting evidence other than in accordance with paragraphs 21 and 22 shall be dispensed with
- 24. Any creditor shall be at liberty to apply to vary or discharge this Order in respect of the insolvency proceeding in which that creditor is a creditor within 28 days of the date upon which the advertisement required under paragraph 21 (1) appears in the London Gazette
- 25. In respect of those appointments made pursuant to paragraphs 7, 9 and 11 of this Order, where Mr Law was previously empowered to act jointly and severally with Mr Sallabank
 Mr Walker shall also be empowered to act jointly and severally with Mr Sallabank

Costs and liberty to apply

- 26. There be no order on the Applicants' and Respondents' costs of this Application save that it is ordered that any costs occasioned by or consequential upon this Application insofar as they relate to a specific insolvency (including, without limitation, the costs of obtaining any release from the Secretary of State pursuant to r4 121(3)(b), r4.122(3)(b) or r.6.135(3) shall be fixed and paid in the ordinary way as remuneration or as costs and expenses of such insolvency
- There be liberty for the Applicants and Respondents to apply for further directions should they see fit
