NOTES TO THE FINANCIAL STATEMENTS

1. Accounting policies

Basis of preparation

The financial statements of the company are prepared under the historical cost convention and comply with applicable UK accounting standards. The bases used are consistent with those used in the previous year.

The company acts as a trustee and nominee for the purposes of administering the Guinness Brewing (UK) 1996 Profit Sharing Scheme, an Inland Revenue approved Profit Sharing Scheme. Shares are held for the beneficial ownership of UK employees of the Diageo group. Profit Sharing Schemes are being phased out after the introduction by the Inland Revenue of the Share Incentive Plan (SIP) and, following 19 October 2004 when the remaining shares held by this company will be transferred to the beneficiaries, there will no longer be any activity.
