Basis of preparing the financial statements

The financial statements have been prepared under the historical cost convention.

Going concern

It is the directors' opinion that the company is a going concern for the foreseeable future.

Turnover

Turnover represents service charge income charged to occupiers of the Havens in respect of administrative expenses incurred.

Taxation

Taxation for the year comprises current and deferred tax. Tax is recognised in the Income Statement, except to the extent that it relates to items recognised in other comprehensive income or directly in equity.

Current or deferred taxation assets and liabilities are not discounted.

Current tax is recognised at the amount of tax payable using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date.
