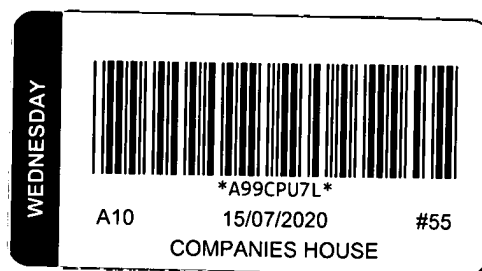


Going concern

The company had no employees during the current and the preceding year.


