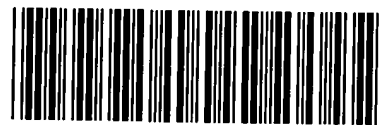

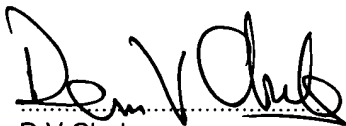
Going concern

1 General information
