## Report of the trustees (incorporating the directors' report) For the year ended 31st March 2020

The Trustees present their report and financial statements for the year ended 31st March 2020. The trustees who are also directors of The Architecture Foundation for the purposes of company law and who served during the year and up to the date of this report are set out in page 1.

#### Structure, governance and management

The Company is registered as a charitable company limited by guarantee and was set up by a Memorandum of Association on 30th October 1991. In 2012, a comprehensive review of governance was undertaken, resulting in a newly ratified Memorandum and Articles of Association in November 2012, which are fully compliant with current charity and company law.

The management of the Company is the responsibility of the Trustees who are elected and co-opted under the terms of the Articles of Association. Day-to-day running of the organisation is delegated to the Director.

The Architecture Foundation's policy regarding the appointment and retirement of the Trustees is laid out in full within our Articles of Association, on file with the Companies House. Newly appointed Trustees receive in person briefings with the Chairman, Simon Allford, and an induction pack including the relevant forms to be submitted to Companies House, the Charity Commission and our internal files.

#### Objectives and activities

Established in 1991 as the UK's first independent architecture centre, The Architecture Foundation has organised hundreds of design initiatives, events, exhibitions and education programmes in public venues across Britain and internationally. Until March 2015, The AF was an Arts Council England National Portfolio Organisation.

The AF's activities continue to be guided by its current mission statement:

The Architecture Foundation seeks to expand the conversation about architecture and urbanism in London. It pursues this mission by:

- supporting the city's architects at the beginning of their careers
- providing a platform for the best architects from across the world to contribute to thinking about London's future
- educating London's citizens about the city's built heritage and empowering them to contribute to discussions about its development

The AF's Board of Trustees have paid due regard to the Charity Commission's guidance on public benefit in deciding which activities the Company should undertake.

#### Programme Summary 2019 - 2020

**APRIL 2019** 

4th April 2019, Megacrits: CASS

All schools are invited to interpret our Megacrits guide in a way that reflects their teaching and ethos. The Cass hosted a half-day exploration of how students and practitioners are approaching the future of housing in the UK. The program of crits and talks sought to investigate existing housing models, and develop a series of diverse approaches to the challenges of the current context.

#### New Architecture Writers

In March 2019, a second cohort was recruited to the New Architecture Writers course, the Architecture Foundation supported programme directed at young critics from BAME backgrounds. The nine successful candidates were provided with a year of free writing tutorials, which concluded with their curation of a series of online public events on the Architecture Foundation social media channels.

#### London Architecture Guide

The Architecture Foundation has continued to commission new entries for its free-to-download London Architecture Guide app. Edward Jones and Christopher Wodward authored 20 new entries for the app in 2019-20, which served to add recent significant buildings and to expand the app's geographic scope.

Financial review 2019-20

#### Summary

Underlying income declined -22% in the financial year to 31st March 2020, as the multi-year income growth trend reversed and set us back to the income level of 2-3 years ago. This results in a loss of close to £30k for the year, or a profit margin or -10.3% compared to +6.1% in 2018-19.

#### Income and profit

Underlying income for the period was -23% lower at £295.7 thousand (FY18-19: £377.9 thousand). As before, this excludes the contribution-in-kind for legal advice from Herbert Smith Freehills (offset by an equal expense) which amounted to £19,385.60in the year.

Since the termination of the AF's Arts Council funding in late 2014-15, the total underlying income had seen strong progress for years as the charity became more reliant on contributions from supporters and income from activities and events. In 2019-20, both categories took a sharp leg down, declining -21% and -26% respectively. Nonetheless, these remain the backbone of our income with supporter contributions now at 51% of all underlying income (prior year: 50%), lecture/event ticket sales at 19% (prior year: 20%), far ahead of other important sources like walking tours (11%), book sales at 6%, member contributions (4%) and sponsorship (5%).

The principal source of income remains the contributions we receive from supporters and, to a lesser extent, members. As mentioned in the last annual report, we started rolling over the first supporter vintages of the 2015-16 fundraising drive (these signed up for an initial 3-year support contribution) and had been facing higher-than-anticipated drop-off rates. At the end of 2019-20, the director, office manager, accountant and treasurer did a comprehensive review of outstanding invoices from all supporters and wrote down a substantial amount of previously recognised income. This review resulted in a major headwind to the 2019-20 supporter income which dropped -21% compared to the prior year. Since the end of the 2019-20 financial year, our efforts to recover any outstanding invoices and attract new supporters have continued and were strengthened by strong supporter engagement from our shift to an online program in a covid19 environment. We still target to keep the supporter contributions at a level which covers the fixed salary costs of the AF (see below).

The second income stream is the sale of tickets for events and talks, which dropped -26% to £56.7 thousand in FY19-20. By the end of the year, the event program was already badly hit by the fallout of the pandemic. We expect this to deteriorate further in 2020-21 and maybe even beyond that. We are exploring income sources to offset this in a world where the AF program has shifted online.

On the cost side, the total underlying expenses for the period declined by -5% to £326.3 thousand (FY16-17: £344.1 thousand), again excluding the non-cash cost for legal services from Herbert Smith Freehill. Compensation expenses were +4% higher at £168.6 thousand and increased to 58% of the underlying income (FY18-19: 42.8%) which is the highest level in at least five years. Due to the departure of the deputy director, the compensation expenses are expected to decline by about 15-20% in 2020-21. Underlying non-compensation costs declined -14% to £157.7.

The cost-to-income ratio increased from 91% to 112%, resulting in a loss for the period of £-34.8 thousand (prior year: 33.8 thousand profit). A good part of this loss relates to the non-cash impact of writing down outstanding invoices as discussed above.

#### Balance sheet and financial position

Total assets amounted to £194.4 thousand at 31st March 2020, including £113.6 thousand in cash balances and £75.8 thousand in accounts receivables. Net assets £131.2k.

Our cash balance at year end covers around 83% of our expected compensation cost for the following year (up from 78% at the end of the prior year).

#### Outlook

The Covid19 pandemic renders any meaningful outlook impossible. The activities of the AF have been badly hit by the lockdown but we quickly embarked on an ambitious and well-received digital program. Since the end of the financial year 2019-20 in March 2020, we have been able to keep our underlying cash balance broadly flat which displays a step-up in collection of outstanding invoices and attracting new supporters. On the cost side, we expect a 15-20% decline in compensation costs for 2020-21 while other costs should also come down materially as most of these were linked to our events program. While we strife to report a small profit, it is not possible to provide any meaningful perspective on this for 2020-21 given the ongoing uncertainty. However, our cash position allows us to continue the operation of The Architecture Foundation for the coming year.

#### Statement of Trustees' Responsibilities

The Trustees are responsible for preparing the Annual Report and the financial statements in accordance with applicable law and United Kingdom's Generally Accepted Accounting Practice.

Company and charity laws applicable to charities in England and Wales require the Trustees to prepare financial statements for each financial year, which give a true and fair view of the state of affairs of the Charity and of the surplus or deficit of the Charity in that period. In preparing those financial statements the Trustees have:

- selected suitable accounting policies and applied them consistently;
- observed the methods and principles in the Charities SORP;
- made judgements and estimates that are reasonable and prudent;
- stated whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepared the financial statements on a going concern basis (unless it is inappropriate to presume that the Charity will continue in operation). The Trustees have overall responsibility for ensuring that the Charity has an appropriate system of controls, financial and otherwise. They are also responsible for keeping proper accounting records that are sufficient to show and explain the Charity's transactions and disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the detection and prevention of fraud and other irregularities. The Trustees are responsible for the maintenance and integrity of the corporate and financial information included on the Company website. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

#### **Small company provisions**

## Notes to financial statements for the year ended 31 March 2020

#### 1. Accounting policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and the preceding year.

#### 1.1. Statement of compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and Republic of Ireland', the Statement of Recomended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

#### 1.2. Incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Voluntary income is received by way of grants, donations and gifts and is included in full in the statement of financial activities when receivable. Grants where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.

Donated services and facilities are included at the value to the charity where this can be quantified. The value of services provided by volunteers has not been included.

Gifts donated for resale are included as incoming resources within activities for generating funds when they are sold.

Grants, including grants for the purchase of fixed assets, are recognised in full in the statement of financial activities in the year in which they are receivable.

#### 1.3. Resources expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Costs of generating funds comprise the costs associated with attracting voluntary income and the costs of trading for fundraising purposes including the charity's shop.

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Support costs are those costs incurred directly in support of expenditure on the objects of the charity and include project management.

#### 1.4. Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less accumulated depreciation. Depreciation is provided at rates calculated to write off the cost less residual value of each asset over its expected useful life, as follows:

Fixtures, fittings and equipment - 25% straight line
