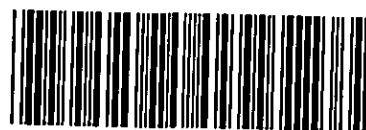

We have audited the financial statements of Sweets Way (Block C) Management Company Limited for the year ended 31 March 2011 set out on pages 5 to 8. 

### **6 Contingent liabilities and transactions with directors**
