Principal activity, business review and future prospects

Historically and through the year ended 31 December 2015, Hypo Property Services Limited ("the Company") principal activity was the management of commercial property investments by fellow subsidiaries or third parties. In the financial year, the Company holds a 50% investment in an affiliated entity.

At the annual Board of Directors meeting held on 7 November 2014, the directors resolved to cease commercial activities and close the Company. As the directors intend to liquidate the Company following the settlement of the remaining net assets, they have not prepared the financial statements on a going concern basis. The results for the year ended 31 December 2015 are summarised in the income statement on page 5.

Notes

(forming part of the financial statements)

1. General information

Hypo Property Services Limited is a private company limited by shares and is incorporated and domiciled in the United Kingdom. The address of its registered office is 20-22 Bedford Row, London, WC1R 4JS. The Company is a wholly owned subsidiary of Flint Nominees Limited ("Parent").

2. Accounting policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the financial statements.

Basis of preparation

These financial statements have been prepared in accordance with applicable United Kingdom accounting standards, including Financial Reporting Standard 102 – 'The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland' ('FRS 102'), and with the Companies Act 2006. The financial statements have been prepared in accordance with the regulations of FRS 102 section 1A "Small Entities" and on the historical cost basis.

Financial Year 2015 is the first year that the Company has presented its results under FRS 102 section 1A "Small Entities". The last financial statements prepared under the previous UK GAAP were for the year ended 31 December 2014. In context of the first time adoption of the new standard FRS 102 no transition effects occurred and no comparative prior year amounts had to be restated.

The financial statements are presented in Sterling (£).

Prior to 2014, these financial statements have been prepared on a going concern basis. At the 7 November 2014 annual Board of Directors meeting, the directors resolved to cease commercial activities as they intend to liquidate the Company following the settlement of the remaining net assets. The directors have not prepared the financial statements on a going concern basis. However, there are no adjustments necessary to the amounts at which the remaining net assets are included in these financial statements.

The audit fee of these financial statements is borne by the Parent undertaking in both the current and preceding financial years and in the amount of £1,200 (2014: £1,200).

Taxation

The charge for taxation is based on the profit for the year and takes into account taxation deferred because of timing differences between the treatment of certain items for taxation and accounting purposes.

Deferred taxation is recognised without discounting, in respect of all timing differences between the treatment of certain items for accounting and taxation purposes which have arisen but not reversed by the balance sheet date.
